

#### STORMWATER PIPE REPLACEMENT AGREEMENT

THIS AGREEMENT made this \_\_\_\_\_ day of \_\_\_\_\_, 2016, by and between FAYETTE COUNTY, GEORGIA, a political subdivision of the State of Georgia, acting by and through its Board of Commissioners, hereinafter referred to as the "County," and Country Lake Home Owners Association, Inc., a duly organized Georgia corporation, hereinafter referred to as the "HOA," for the purpose of constructing, reconstructing, repairing and maintaining that certain stormwater pipe located within the Country Lake Subdivision, hereinafter "Country Lake" in Fayette County, Georgia, hereinafter the "Agreement."

WHEREAS, the Board of Commissioners of Fayette County, Georgia is the duly organized governing authority of Fayette County, Georgia; and

WHEREAS, Country Lake Home Owners Association, Inc. is the duly organized governing authority for Country Lake; and

WHEREAS, a 24-inch diameter stormwater pipe has failed within Country Lake causing a substantial sinkhole in the amenities area of Country Lake; and

WHEREAS, the County and the HOA desire to work together to effect the necessary repairs and/or replacement of the aforementioned stormwater pipe; and

WHEREAS, the County's participation in the repairs and/or replacement of the aforementioned stormwater pipe shall be capped at an amount certain.

NOW, THEREFORE, FOR AND CONSIDERATION of the mutual premises contained herein and for other good and valuable consideration, the receipt and sufficiency thereof being

hereby acknowledged by both the County and the HOA, the County and the HOA hereby agree as follows:

#### WITNESSETH:

1.

The County is the owner of all right-of-ways contained within Country Lake. The stormwater drainage system collects stormwater from the right of ways, and other areas, and channels the stormwater to its appropriate destination. The catch basin located at or near 255 Morning Springs Walk in the amenities area of Country Lake, hereinafter the "Catch Basin," is a component of the County's stormwater system within Country Lake.

2.

A 24-inch diameter stormwater pipe is attached to the Catch Basin, hereinafter the "Stormwater Pipe," perpendicular to the right-of-way at or near 255 Morning Springs Walk, hereinafter the "Subject Property". The Stormwater Pipe extends and conveys stormwater from the Catch Basin to a point approximately 300 feet into the Subject Property.

3.

In late December 2015, the Stormwater Pipe failed at a point some 50 feet from the rightof-way on the Subject Property. The failure of the Stormwater Pipe resulted in a sinkhole of substantial width and depth on the Subject Property. The HOA desires to, among other things, replace the entire Stormwater Pipe from the Catch Basin to a point approximately 300 feet into the Subject Property. A portion of this Stormwater Pipe lies within the County's right-of-way of Morning Springs Walk and is owned by the County. The HOA will need to replace that portion of the Stormwater Pipe which is owned by the County in order to successfully connect with the Catch Basin and ensure the proper working condition of the replacement 24-inch diameter

stormwater pipe. The County agrees to reimburse the HOA in an amount not to exceed TWENTY-FIVE THOUSAND AND 00/100 (\$25,000.00) DOLLARS, hereinafter the "Maximum Reimbursement," with such participation limited to only that work conducted within the County's right-of-way. In no event shall reimbursement by the County cover any costs of the Project other than those costs attributable to the work performed within the County's right-ofway. Should the costs of the Project within the County's right-of-way be an amount less than the Maximum Reimbursement, the County shall only pay the amount which is less than the Maximum Reimbursement.

4.

The HOA will employ a contractor, hereinafter the "Contractor", to replace the full length of the Stormwater Pipe, with such replacement to include that portion of the Stormwater Pipe owned by the County, hereinafter the "Project." The HOA will ensure that the Contractor will follow all County minimum standards for the Project for that portion of the Project within the County's right-of-way. Further, the HOA will ensure that the Contractor will follow all requirements and regulations of the County in its performance of the Project. Materials and construction methods used on work within the right-of-way of Morning Springs Walk shall meet all applicable Fayette County Development Regulations and the Georgia Department of Transportation's Standard Specifications Construction of Transportation Systems, latest edition.

5.

The County shall reimburse the HOA for that portion of the Project owned by the County and replaced by the Contractor subject to the limitation contained within Paragraph 3 of this Agreement. Said reimbursement by the County shall occur after completion of the Project. The HOA shall provide a written invoice to the County and the County shall remit payment no later

than 30 days from the receipt of the invoice. The County hereby grants permission to the HOA to allow its Contractor to work within the right-of-way of Morning Springs Walk, to perform all necessary work for the Project.

6.

Time is of the essence. The HOA shall cause the Contractor to complete the Project without interference with the traveling public along Morning Springs Walk. The HOA shall be responsible for providing traffic control throughout the duration of the Project. Traffic control shall be in accordance with the Manual on Uniform Traffic Control Devices, latest edition. The Project shall be complete within 60 days of the issuance of a Notice to Proceed by the HOA. The HOA shall notify the County at least 24 hours before work is initiated.

#### 7.

The HOA is responsible for locating and coordinating with any utilities within the Project, as well as meeting all State and Federal Utility Notification Requirements (e.g., Utility Locates). The HOA shall be responsible for damages to any utility as a result of the Project.

8.

The parties agree that ownership of the Stormwater Pipe is shared by the County and the HOA. The ownership is shared in such a manner that the County's duties and responsibilities for the Stormwater Pipe arise by virtue of the County's ownership of the aforementioned portion of the Stormwater Pipe. contained herein, the HOA shall cause the Contractor to replace that portion of the Stormwater Pipe within the right-of-way of Morning Springs Walk.

9.

The County's participation in this Agreement may not be construed as an admission by the County that it owns more of the Stormwater Pipe than that portion of the Stormwater Pipe contained within the right-of-way of Morning Springs Walk. In fact, the County denies any construction of this Agreement which seeks to place more duties and responsibilities on the County in addition to those duties and responsibilities borne by the County for that portion of the Stormwater Pipe contained within the right-of-way of Morning Springs Walk.

#### 10.

This Agreement shall be binding upon all parties hereto and their respective heirs, executors, administrators, successors, and assigns.

#### 11.

The HOA agrees and covenants that it will cause the Contractor to purchase and maintain such insurance as will protect the County from claims set forth below which may arise out of, or result from, the Contractor's execution of the Project, including that portion of the Project contained within the right-of-way of Morning Springs Walk, whether such execution be by the Contractor, any subcontractor, or by anyone directly or indirectly employed by any of them, or by anyone for whose acts any of them may be liable:

(a) Claims under workmen's compensation, disability benefit and other similar employee benefit acts;

(b) Claims for damages because of bodily injury, occupational sickness or disease, or death of employees;

(c) Claims for damages because of bodily injury, sickness or disease, or death of any person other than employees;

(d) Claims for damages insured by usual personal injury liability coverage which are sustained (1) by an person as a result of an offense directly or indirectly related to the employment of such person by the Contractor, or (2) by any other person; and

(e) Claims for damages because of injury to or destruction of tangible property, including loss of use resulting therefrom.

#### 12.

The HOA will indemnify and hold harmless the County and its agents and employees from and against all claims, damages, losses and expenses including attorney's fees arising out of or resulting from the performance of the Project, including that portion of the Project contained within the right-of-way of Morning Springs Walk, provided that any such claims, damage, loss or expense is attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property including the loss of use resulting therefrom; and is caused in whole or in part by any negligent or willful act or omission of the Contractor, and subcontractor, anyone directly or indirectly employed by any of them or anyone for whose acts any of them may be liable. In any and all claims against the County, or any of its agents or employees, by the HOA, any employee of the HOA, the Contractor, any subcontractor, anyone directly or indirectly employed by any of them, or anyone for whose acts any of them may be liable, the indemnification obligation shall not be limited in any way by any limitation on the amount or type of damages, compensation or benefits payable by or for the Contractor or any subcontractor under Workmen's Compensation acts, disability benefit acts or other employee benefits acts.

For purposes of notification under the terms and conditions of this Agreement, all notices to the parties will be presumed delivered within three (3) business days of either party placing same in the United States mail with adequate postage affixed thereon and addressed as follows:

#### Request

Funding to develop a countywide brand and implement a marketing strategy for economic development and talent recruitment

#### Purpose

Counties successful in economic and community development often implement a cohesive branding strategy that local marketing organizations like chambers, economic development organizations, and convention and visitors bureaus, as well as county and municipal governments can leverage.

#### Objectives

To create a brand and marketing strategy that not only positions Fayette County in a positive light but is memorable and stands out among the competition. The branding strategy has three primary objectives:

- Economic Development To increase awareness of Fayette County and increase the number of requests for information and, in turn, the number of successful relocations and expansions.
- Talent Recruitment To position Fayette County as the choice for young adults starting families, particularly those who place a high value on education
- Community cohesiveness To help foster community and sense of place by creating a brand that can be used across many sectors and target audiences

#### Brief Statement of Relevant Facts

#### Traditional Economic Development Marketing

Market fragmentation and splintering of media markets has made it increasingly difficult for any product or service to stand out and the business of community marketing is no different. The days are gone where an ad in Site Selection magazine or the school rankings in U.S. News and World Report were the primary ways to attract commercial investment and the people to become part of the community. The Fayette County Development Authority (FCDA) is in the process of rebuilding its marketing strategy. The first step is identifying target industries. FCDA has identified the following:

- Aviation/Aerospace
- Advanced Manufacturing
- Data Processing
- Film/New Media
- Headquarters
- IT

The new branding campaign development process will keep in mind these target markets as it comes up with concepts and strategy.

#### **Talent Recruitment Marketing**

Now more than ever, companies in the process of relocating and expanding put a premium value on having the right workforce.

Companies in Fayette County's target clusters demand a workforce pipeline that is trained and up-todate in the fields of engineering and technology. Fayette County has the oldest median age in the metro Atlanta area and existing industry is concerned about attracting young employees to address current workforce need and an increasing demand as the existing workforce retires. A community brand and marketing strategy can assist our existing businesses in their efforts to attract young talent to their businesses and to Fayette County.

Branding campaigns and marketing plan implementation can be expensive. A small county like Fayette is not in a position to launch a nationwide campaign to attract relocations and expansions or talent. In traditional business recruitment, Fayette County can rely on statewide and regional marketing programs.

While traditional economic development marketing is a business-to-business strategy, talent recruitment is a business-to-consumer strategy and is significantly more expensive and difficult to execute. Fortunately, the Metro Atlanta Chamber has launched the ChooseATL campaign and has asked the smaller chambers to partner with them in this endeavor. The Fayette Chamber is currently discussing with the Metro Atlanta team on letting our county be the test community on how to best leverage that partnership. They will do the heavy lifting on the marketing but it is up to Fayette County to have the right messaging when people we are targeting find Fayette County through the ChooseATL campaign. We currently have no message.

#### Fayette Visioning Implementation Plan

In 2014, Fayette Visioning included a countywide brand as one of its strategies in the five-year implementation plan. Fayette Visioning, in partnership with the Fayette Chamber of Commerce and the FCDA, has been identified as the best organization to create and house the branding for Fayette County.

Fayette Visioning is in the process of assembling a committee to oversee the process. Volunteers active with Fayette Visioning have stepped forward and currently include representatives from the Fayette Chamber of Commerce, Fayette Economic Development Authority, the Metro Atlanta Chamber of Commerce, the Fayette County Commission and the consultant that has drafted City of Fayetteville's

economic development plan. The next step is to reach out to the municipalities and school board for representation as well as Peachtree City's CVB.

#### Specific Conclusion and Request

The expected cost to develop a brand and a marketing campaign and initial plan execution is expected to be between \$40,000 to \$60,000. Until the bid process and selection occurs, the cost is speculative.

Fayette Visioning will be making a request to all local governments as well as the private sector to invest in this endeavor. Since the County is responsible for the budget for the County's economic development authority and the primary purpose of the program is economic development and talent recruitment, Fayette Visioning seeks \$25,000 from Fayette County.

The funds will be used to pay for a logo and branding design and for professional recommendations on a marketing strategy including, but not limited to, social media. We anticipate the branding launch to occur no later than the fourth quarter of 2016. Marketing implementation will begin at that time and remaining funds will be used to implement the marketing strategy. An ongoing marketing strategy will likely require additional funds in future budgets but it is anticipated the requests will not be at the same level since the plan development will not be part of the request.

Welcome to the meeting of your Fayette County Board of Commissioners. Your participation in County government is appreciated. All regularly scheduled Board meetings are open to the public and are held on the 2<sup>nd</sup> and 4<sup>th</sup> Thursday of each month at 7:00 p.m.

#### Call to Order

Chairman Oddo called the March 24, 2016 Board of Commissioners meeting to order at 7:05 p.m. County Administrator Steve Rapson and County Clerk Floyd Jones were absent from the meeting.

#### Invocation by Vice Chairman Ognio

Vice Chairman Ognio introduced- Associate Pastor Steven Chambers who is the Associate Pastor of Sunday School, Discipleship and Children's Ministry at Woolsey Baptist Church. Pastor Chambers offered the Invocation.

#### **Pledge of Allegiance**

Vice Chairman Ognio led the Board and audience in the Pledge of Allegiance.

#### Acceptance of Agenda

Commissioner Ognio moved to accept the Agenda as presented. Commissioner Barlow seconded the motion. The motion passed 5-0.

#### **PROCLAMATION/RECOGNITION:**

#### 1. Proclamation to proclaim the month of April as "National Alcohol Awareness Month" in Fayette County.

Commissioner Barlow read the proclamation on behalf of the Board declaring April as "National Alcohol Awareness Month" in Fayette County. Pam Reed and Michael Mumper, representatives from AVPride were present to accept the proclamation. Ms. Reed and Mr. Mumper gave thanks to the Board for passing the Social Host Ordinance last year and shared with the audience a three minute public service announcement video featuring Sheriff Barry Babb and other law enforcement officers from the municipalities. A copy of the request, identified as "Attachment 1," follows these minutes and is made an official part hereof.

#### **PUBLIC HEARING:**

Chairman Oddo informed that there were additional documents on the dais. The documents were part of the agenda package. He stated that one of the items was the signed document for Public Hearing #4 and the other item was larger copies of the maps that accompanied- Public Hearing items #3 and #4.

2. Public Hearing of staff's recommendation to transfer an existing 2016 Retail Alcohol, Beer and Wine License (License #C15-00628) from Nouman Chaudhry to Sajan Paul Chirauil and Abraham M. Kalathil, doing business as St. Mary's BP, LLC, which is located at 1866 SR 85 North, Fayetteville, Georgia.

Community Development Director Pete Frisina read the rules for public hearings into the record. A copy of the rules for public hearing, identified as "Attachment 2," follows these minutes and is made an official part hereof.

Mr. Frisina briefed the Board that the Code Enforcement officers have looked at this request and the applicants have met all the requirements.

There were no public comments in favor of or in opposition to- this item.

Commissioner Rousseau made a motion to approve staff's recommendation to transfer an existing 2016 Retail Alcohol, Beer and Wine License (License #C15-00628) from Nouman Chaudhry to Sajan Paul Chirauil and Abraham M. Kalathil, doing business as St. Mary's BP, LLC, which is located at 1866 SR 85 North, Fayetteville, Georgia. Commissioner Barlow seconded the motion. Discussion followed.

Commissioner Ognio referenced the supporting document and questioned that there were "a lot of check marks missing" from the documents. Mr. Frisina stated that since this is a transfer, the information would be in the original license. Commissioner Ognio stated that he understood but that the way the information was presented it looks like the information is missing. Mr. Frisina stated that in the future he will make sure that the Board is provided that information. Commissioner Rousseau asked if it was proper to approve this item pending verification that the "missing check marks" are filled in. Attorney Dennis Davenport stated that it was appropriate.

Commissioner Rousseau amended the motion to approve staff's recommendation to transfer an existing 2016 Retail Alcohol, Beer and Wine License (License #C15-00628) from Nouman Chaudhry to Sajan Paul Chirauil and Abraham M. Kalathil, doing business as St. Mary's BP, LLC, which is located at 1866 SR 85 North, Fayetteville, Georgia and to also include verification of the items not checked off on the documentation. Commissioner Barlow amended his second. There was no further discussion. The motion passed 5-0. A copy of the request, identified as "Attachment 3," follows these minutes and is made an official part hereof.

# 3. Public Hearing of the request of Petition No. 1254-16, Gary and Kaora Sloan, Owner, and Mark Whitley, Agent, to rezone 1.50 acres from A-R to O-I to develop an Office Building with said property located in Land Lot 7 of the 6th District and fronting on S.R. 74 South.

Mr. Mark Whitley with Whitley Engineering presented this item to the Board. He stated that the request is to take 1.5 acres off the front side of the property to be used to build a home inspection business and for the remaining back part of the property to be used for future plans of building a home for Mr. Sloan.

Commissioner Brown asked if the duplex format would be used for the building. Mr. Whitley stated that this would not be set up as a duplex.

Chairman Oddo asked if there would be parking in the rear. Mr. Whitley stated that it was discussed that the parking would be moved to either the side or the back. He confirmed that it would change. He stated that there would only be one shared driveway to be used by both parcels. He verified that it would be the 1.5 acre track that is being cut out for the commercial use and the remaining remnant which is approximately 6.2 acres to build the house.

There were no public comments in favor of or in opposition to this item.

Commissioner Barlow stated that he is a good acquaintance of Mr. Sloan and recused himself from voting on this item.

Commissioner Brown made a motion to approve Petition No. 1254-16, Gary and Kaora Sloan, Owner, and Mark Whitley, Agent, to rezone 1.50 acres from A-R to O-I to develop an Office Building with said property located in Land Lot 7 of the 6th District and fronting on S.R. 74 South. Commissioner Rousseau seconded the motion. Discussion followed.

Commissioner Brown inquired about the language on page thirteen of the agenda package. He stated that under the Recommendations section it states, "Continuation of sidewalks on both sides of Highway 74 would be a requirement for the office development." He asked if that is by ordinance or if it needs to be listed as a condition. Mr. Frisina stated that section is an insert from the actual ordinance. He stated that the Land Use Plan is a recommending document and that the recommendation is that the sidewalk be there and in the next section, on page five, it is listed as a requirement, which is taken from the Zoning Ordinance.

Commissioner Ognio asked if it was just a requirement for O-I zoning or would the sidewalk go across the entire strip. Mr. Frisina stated that it is only for the property that is being rezoned. Commissioner Ognio asked if a condition could be added to include extra sidewalk so that there will not be a piece of the sidewalk missing. Mr. Frisina stated that the other part of the property is not part of the rezoning. Commissioner Ognio stated that he did not think that the county thought this area would be broken down into an O-I and a residential, but since it will be both, the sidewalk gap needs to be addressed.

Mr. Martin stated it is understood that the sidewalk would have to be placed in front of the property being rezoned, but that the decision would be left to Mr. Sloan if he would be willing to include the extra sidewalk. Mr. Sloan agreed to include the extra sidewalk.

Commissioner Brown amended the motion to approve Petition No. 1254-16, Gary and Kaora Sloan, Owner, and Mark Whitley, Agent, to rezone 1.50 acres from A-R to O-I to develop an Office Building with said property located in Land Lot 7 of the 6th District and fronting on S.R. 74 South and to extend the continuation of the sidewalk along both parcels. Commissioner Rousseau amended the second. The motion passed 4-0 with Commissioner Barlow abstaining from the vote. Copies of the request, Rezoning Ordinance 1254-16, and Rezoning Resolution 1254-16, identified as "Attachment 4," follow these minutes and are made an official part hereof.

# 4. Public Hearing of the request of Petition No. 1255-16, Morris E. Lewis Jr., Owner, rezone 2.15 acres from A-R to R-70 to develop a Single-Family Residential Subdivision with said property located in Land Lot(s) 224 & 225 of the 13th District and fronting on Wagon Wheel Trail with one (1) condition.

Mr. Frisina stated that both the Planning Commission and staff recommend approval with the one recommended condition. He added that it is in compliance with the Land Use Plan and that the condition deals with the dedication of right-of-way along Wagon Wheel Trail.

Mr. Lewis briefed the Board that he promised his wife a dream house and in order to keep his promise to his wife he will need to take a portion of the property and sell it to help pay to build the new dream home.

There were no public comments in favor of or in opposition to this item.

Commissioner Brown made a motion to approve Petition No. 1255-16, Morris E. Lewis Jr., Owner, rezone 2.15 acres from A-R to R-70 to develop a Single-Family Residential Subdivision with said property located in Land Lot(s) 224 & 225 of the 13th District and fronting on Wagon Wheel Trail with one (1) condition. Commissioner Barlow seconded. Discussion followed.

Commissioner Brown asked Mr. Frisina to read the condition for the record. Mr. Frisina stated that the condition is "that the owner/developer would provide at no cost to Fayette County a quit claim deed for thirty feet of right-of-way as measured from the centerline of Wagon Wheel Trail prior to the approval of the final plat and said dedication area shall be shown on the final plat."

The motion to approve Petition No. 1255-16, Morris E. Lewis Jr., Owner, rezone 2.15 acres from A-R to R-70 to develop a Single-Family Residential Subdivision with said property located in Land Lot(s) 224 & 225 of the 13th District and fronting on Wagon Wheel Trail with one (1) condition. Commissioner Barlow seconded. The motion passed 5-0. Copies of the request, Rezoning Ordinance 1255-16, and Rezoning Resolution 1255-16, identified as "Attachment 5," follow these minutes and are made an official part hereof.

#### CONSENT AGENDA:

Commissioner Rousseau asked to remove Consent Agenda Item #6 for discussion.

Commissioner Brown made a motion to approve the Consent Agenda with the removal of item six for discussion. Commissioner Ognio seconded. The motion passed 5-0.

- 5. Approval to continue the agreement between Fayette County and Georgia Emergency Management-Homeland Security as outlined in the Statewide Mutual Aid and Assistance Agreement, and to authorize the Chairman to sign the agreement. Copies of the request and agreement, identified as "Attachment 6," follow these minutes and are made an official part hereof.
- 6. Approval of staff's recommendation to enter into an Independent Contractor Agreement with Peter D. Nelms to provide grant management services as outlined in the agreement, and to authorize the Chairman to sign the agreement and any related documents.

Commissioner Rousseau stated that he spoke with staff and one- issue that needs clarity pertained to Chief Scarbrough and the Fire Department. He understood the responsibilities and that -contractor Pete Nelms would be housed in the Finance Department. He explained that the contractor's pay would come from the Finance budget and that it will be the Finance Department's responsibility to oversee Mr. Nelm's work. Commissioner Rousseau asked for the Board's consideration to make the motion to properly reflect that the monies are coming from Finance and that the position will be in Finance as well.

Attorney Davenport stated that in paragraph two, the date should be changed from June 31 to June 30. Chairman Oddo asked that the exact term of the contract be read.

Mr. Davenport read: "The initial term of this agreement shall commence on April 1, 2016 and extend to June 30, 2016. Thereafter this agreement may be renewed by the County for two additional one year renewal terms, which renewal shall be by letter or other written correspondence to the County or contractor sixty days prior to the expiration of the initial term or the then current renewal term."

Chairman Oddo asked if the expiration date June 30, 2016 or 2017. Mr. Davenport stated that the expiration is 2016 for the first term so that it aligns with the budget year.

Commissioner Rousseau referenced page 66, Section 5.3, second line. He read, "Contractor represents that he will not bring with 'her' to the County." He stated that it should read "him" and that for future reference maybe the contract should read "him or her".

Commissioner Rousseau made a motion to approve to enter into an Independent Contractor Agreement with Peter D. Nelms to provide grant management services as outlined in the agreement, with the proposed amendments to reflect that the dollars and the position will be authorized through the Finance Department, to include the change of date from June 31 to June 30, to change the word "her" to "him" in Section 5.3 and to correct the addresses on page 69 for the County Administration Office, and to authorize the Chairman to sign the agreement and any related documents. Commissioner Barlow seconded. The motion passed 5-0. Copies of the request and contract, identified as "Attachment 7," follow these minutes and are made an official part hereof.

- 7. Approval of the Water Committee's recommendation to reimburse Mr. Liston Garland \$1,076.00 landscaping on his property, due to damage from a water main break and delegate the authority for the Water System Director to settle damage related claims against the Water System up to \$2,000 with the Water Committee's approval. A copy of the request, identified as "Attachment 8," follows these minutes and is made an official part hereof.
- 8. Approval of the March 10, 2016 Board of Commissioners Meeting Minutes.

#### **OLD BUSINESS:**

There was no Old Business on the Agenda.

#### **NEW BUSINESS:**

There was no New Business on the Agenda.

#### PUBLIC COMMENT:

**Bonnie Williamson:** Mrs.Williamson spoke regarding a comment on a public social media site that referred to an ethnic group in Fayette County. She stated that a public official made the comment. She stated that she would like to see the county continue the relationship that it has between ethnic groups and not to split them apart. She urged others not to stereotype groups.

**Dr. Shirley Kilgore:** Dr. Kilgore, President of the Country Lake Homeowners Association, spoke regarding an appeal for assistance from the county. She gave some background regarding an issue with a sink hole at the property's community center/clubhouse. She stated that she was told that the sinkhole emanated from the storm drain pipe on the street. She described the sinkhole as spreading from a few feet to being able to now put a bus in the hole and it is continuing to spread. She stated that the cost to repair the sinkhole is "absorbent" and the association is looking at means to make the repair. She stated that the association is also appealing to county to consider any assistance that can be provided and to evaluate if this would be a county matter.

**Lee Hearn:** Mr. Hearn stated that he is candidate for District 2 Commissioner. He appreciated the opportunity to say "hello" to those viewing from home and that are in the audience.

#### ADMINISTRATOR'S REPORTS:

**Development Authority request to extend position posting:** Chairman Oddo briefed the Board that a request was received from the Development Authority to extend the date for accepting applications for the Development Authority. The County currently has one position posted and there is now another position open. The request was to extend the time so that the other position could be filled as well. He stated that there are currently six received applications. The deadline for making application is Friday, March 25, 2016.

#### **ATTORNEY'S REPORTS:**

**Notice of Executive Session:** County Attorney Dennis Davenport notified the Board that he had one item of Threatened Litigation and review of the March 10, 2016 Executive Session Minutes for consideration in Executive Session.

#### **COMMISSIONERS' REPORTS:**

#### Chairman Oddo:

Lake Peachtree dredging completion: Chairman Oddo announced that rain is in the forecast and that the dredging was completed at Lake Peachtree earlier in the day. He stated that there is still work to be done, but not in the lake. He stated that drain valves have been closed and the lake is filling up.

Weather advisory: Chairman Oddo shared that there is a weather advisory for the evening.

#### **Commissioner Brown:**

Announcement of two events in Fayette County: Commissioner Brown announced that the Beer Festival will take place on April 16 at 11:00 a.m. in the Fayetteville Downtown Square and that all the proceeds will go to charity. He stated that it is hosted by the Kiwanis Club and that there will be live music and a lot of wine and beer choices. He stated that this year there are products from all over Southeastern United States. He also announced that April 23 at 9:30 a.m. the County will host the first ever Water Guardians project. He stated there will be local kayakers and canoers to clean out the water reservoirs. He stated that this first event will take place at Lake Kedron, and he said anyone with a kayak or canoe is invited to volunteer.

#### **Commissioner Ognio:**

Happy Easter: Commissioner Ognio wished everyone that is traveling for Easter to have safe travels.

Lake Peachtree dredging: Commissioner Ognio stated that it is good that the lake is complete.

**Election Season**: Commissioner Ognio shared that election season is "high" and he reminded the citizens that there is another primary that has to do with county officials, state officials and even some federal officials. He urged the citizens to do their "homework" on the candidates and get out to vote on May 24.

#### Commissioner Rousseau:

**Brussel, Belgium tragedy:** Commissioner Rousseau asked everyone to continue to lift up and recognize those that have suffered loss from the tragedy in Brussel. He hoped that as people think of each other's personal safety, that it would- bring healing to the situation as opposed to driving wedges. He mentioned the comments made by Mrs. Williamson and said that he joined in her sentiment.

**Response to Ms. Kilgore's comments:** Commissioner Rousseau stated that he has visited Country Lake on several occasions and the county is aware of the situation and will continue to work on a reasonable dealing of the issue. He appreciated the subdivision's efforts of moving forward.

**Kudos to the staff**: Commissioner Rousseau stated that when citizens want to see tax dollars at work, the county does not put up fancy signs, but a drive through the neighborhoods would show the citizens some road pavings that is taking place. He commended staff for its work and use of the resources in the various communities.

Happy Resurrection Sunday: Commissioner Rousseau wished everyone a Happy Resurrection Sunday / Happy Easter.

#### **Commissioner Barlow:**

**Easter meaning:** Commissioner Barlow thanked everyone for attending. He stated that today he was reflecting on Easter and what it stands for in the Christian community; specifically, the crucifixion,- burial and resurrection of the Lord Jesus Christ. He mentioned a song by the Hoppers entitled "Yahweh". He stated that it was very pleasant to listen to and he encouraged others to listen to the song.

**Belgium tragedy**: Commissioner Barlow stated that he continues to lift up the individuals in Belgium during this tragedy. He stated there are attacks against innocent people and his prayer is that somehow there is a grip made on the rampant evil throughout the world and that it is brought under control.

Lake Peachtree dredging: Commissioner Barlow stated that he drove by the lake and prayed for rain. He thanked God for the rain to come.

**Recipient of the Fred Angel Award**: Commissioner Barlow announced that he was selected by the Board of Health to receive the Fred Agel Award for Governance. He stated that he had received the award and as the Chairman of the Fayette County Board of Health, he was selected from 159 nominees. A photo and press release will be sent to the media. He stated that Fayette County is ranked number one in the State for access to quality healthcare. He stated that the county ranked about fifth or sixth for transporting people there. I would like to be considered for the Library Board. I have been a member and volunteer at The Fayette County Historical Society's Research Center for over 30 years. ## **INTRODUCTION**

The Heritage of Peachtree development is an assisted living facility located in Fayette County, Georgia. The facility is not served by public sewer, rather an onsite wastewater treatment and disposal system which involves the application of septic tanks and subsurface disposal fields in addition to other peripheral equipment. Since being built in 1995, the inhabitants and staff have experienced chronic issues that are a product of septic system malfunctions such as surfacing effluent and noxious unpleasant odors. The purpose of this report is to chronicle the history of the systems' construction, permitting, and performance through review of archived documents as well as discussions with staff members. The review will be combined with some current site studies to help determine potential sources of the issues at hand in order to provide possible remedies on the site.

## **HISTORY**

As the site for Heritage of Peachtree is located outside the Peachtree City city limits, public sewer does not reach the frontage of the property. Thus, the developer was left to consider the only other option of disposing the facility's wastewater on the site. As with any onsite system, the first step was to facilitate a soil study of the property to determine onsite system feasibility. This study was performed in June 1994. While this study cannot be located, a subsequent permit document from the Fayette County Health Department indicated the soil on the site to have a percolation rate of 45 minutes per inch, meaning that water in the soil can travel an inch every 45 minutes through the soil. This rate is considered to be relatively good in this region and acceptable for the proper performance of an onsite system if sized properly. It also should be noted that the site was graded extensively with fill material prior to construction; although, the exact time the grading occured cannot be confirmed.

Fayette County Health Department issued the permit for system construction on January 12, 1995. The determination was made to employ three systems as opposed to one to correlate to the three halls (100, 200, 300) that composed the facility. For the purpose of this discussion, each system will be referred by number with System 1 serving the 100 Hall, System 2 serving the 200 Hall, and System 3 serving the 300 Hall.

The health department determined the total design flow for the facility to be 3,000 gallons per day. In addition to the 100 Hall, System 1 received flow from the kitchen. The system, inspected and approved on June 20, 1995, included a 1,500 gallon septic tank, a 3,000 gallon grease trap, and 160' of disposal trench installed approximately 92" below finished grade in order to place the system below the added fill material and in the native soil. System 2 was inspected and approved on June 16, 1995. The system included one 1500 gallon septic tank and 140' of disposal trench installed 70" below finished grade in order to place the system below the added fill material and in the native soil. System 3 was inspected and approved on June 21, 1995. The system consists of one 1,500 gallon septic tank and 150' of disposal trench installed 60" below finished grade in order to place the system system below the added fill material and in the native soil.

## **THE REPAIRS**

Between the three systems, five documented repairs have been performed since the systems were originally installed. The approximate repair occasions are as follows: -May 1998 on System 3 -April 2003 on System 2 -May 2003 on System 1 -July 2003 on System 3 -May 2007 on System 1

<u>System 1</u>: As indicated above, two repairs were made on this system. This system has presented extra challenges to a successful repair as the added kitchen waste introduces a highly organic component to the waste stream which is harder to treat. The first repair was conducted in 2003 and consists of the addition of 150' of disposal trench to the original 160' of a sand filtered trench to the left of the building to bring the total amount of trench to 310'. A second repair was performed in 2007. This repair involved valving off the line from the original 310' disposal trench lines and installing 355' of new sand filtered trench around to the front of the building at an approximate 90' depth below grade.

<u>System 2</u>: One repair was made on this system. The April 2003 repair involved the installation of 180' of disposal trench in place of and adjacent to the failed trench line installed originally on the right side of the building. The trenches are installed approximately 80" below grade.

<u>System 3</u>: This system is located along the southwest corner of the property. Two repairs were made on this system, the first in May 1998. That repair consisted of an addition of 150' of sand filtered trench added on to the original 150' of disposal trench. The then new trench was installed about 90" below existing grade. The second repair occurred in July 2003 and involved valving of the initial repair system to disjoin it from a newly installed 190' of sand filtered trench installed about 90" below grade. Along with the initial 150' of trench, this leaves a total of 340' of trenches in use currently.

## **PREVAILING ISSUES & DIAGNOSIS**

Present indications are that all three systems are not functioning adequately if at all. The disposal fields on Systems 1 and 3 are taking very little effluent if any; thus, the tanks on each system become filled with influent in short order. Both systems' tanks require pumping every four to six days on average to eliminate most of the accumulated waste stream, occasionally more frequently during periods of rain. System 2 appears to be stressed to a lesser extent. Nonetheless, it's tank must be pumped roughly every two months.

Hydraulic overload is the likely primary reason for the chronic issues experienced at the facility. The original permits for the three systems that were issued in 1995 indicate that the facility is to accept a cumulative hydraulic design flow of 3,000 gallons per day. Taking into account the implied safety factor with design values, the original systems would have accommodated a consistent combined flow around 2,000 gallons per day with occasional higher flows. Recent water meter readings indicate average actual flows between 4,000 and 4,500 gallons per day, roughly double the anticipated amount at initial system permitting. The only other possible issue would involve soils in the area that were not capable of accepting the effluent stream. Original and more recent site soil evaluations indicate this to not be the case. According to the reports, there is a small amount of fill material above the natural soil, which was determined to be a soil that would readily accept effluent from the systems. With this possible cause eliminated, the only plausible explanation is that the systems in place are too small to process the effluent supplied by the facility.

Additionally, System 1 is likely experiencing an organic overload, meaning that the disposal field for this system is not capable of processing the higher strength waste produced from the kitchen at the facility despite the utilization of a grease trap in the current arrangement. Effluent composed of a higher organic content typically requires a system's disposal field to be even larger than the product of the hydraulic demands on the system.

Finally, other secondary conditions that further intensify the situation at hand include:

-The potential introduction of antibiotics and other solutions into the waste stream that are a deterrent to a system's biology, the fuel needed to provide waste treatment. There is no direct evidence of that in this case but is a factor at other comparable facilities.

-All downspouts are directed onto the grounds, often in the vicinity of the three systems. This surface water can potentially increase the hydraulic loading on these subsurface systems.

-Site irrigation can also contribute to the hydraulic load on the systems similar to the above.

-There is not a storm water plan for this development. A significant footprint on the property is paved, meaning that there is heavy runoff during rainy periods to the lowest part of the parking lot towards the southwest corner of the property. This runoff likely affects System 3 more than the others.

## **REMEDIES**

As there is little available virgin footprint remaining on the property, simplistic repairs of the existing systems are not a practical option. A complete reconstruction of the systems appears to be the most credible approach. Remedial options include:

**1.** Abandonment of the existing onsite systems and connection to nearest public sewer. This option is outside the scope of this report and thus will not be discussed.

**2. Continue to pump existing tanks on site as needed.** This is essentially the "do nothing" option involving pumping the tanks at routine intervals as described in this report. Based on historical cost data, the annual cost for this option would be \$80,000 to \$90,000.

3. Overhaul with abandonment/removal of existing systems and construction of new systems in same locations. This approach will be complex and involve a maintenance plan (pumping tanks) during the construction phase. All three disposal fields will be disconnected and excavated from the site. All tanks will remain and be utilized as part of the newly constructed systems. The system capacities will increase the design flow from 3,000 gallons per day to 6,000 gallons per day and include four systems. There will be one system for each hall (1,500 gallons per day each) and a fourth system (1,500 gallons per day) that will exclusively serve the kitchen and washer. All four systems' dispersal fields will be beds composed of an in-line treatment system (contained in filter pipe) immersed in an engineered sand filter to provide two levels of treatment before the effluent reaches the soil. A dosing tank with a pump and controls will be included in all four systems to provide time dosing into the disposal fields. The system serving the kitchen will include both an internal grease interceptor in the kitchen as well as a treatment unit outside after the existing septic and dosing tank. The estimated cost for this plan to be executed is \$390,000. As part of the overall approach to repair, all downspouts shall be diverted away from the disposal fields and water from kitchen drains captured before release into the sewer line. Finally, all irrigation on grass must be curtailed. All other vegetation may be watered, either by potable water or by harvested rainwater captured from the downspouts.

## City Council of Peachtree City Meeting Minutes December 4, 2014 7:00 p.m.

The Mayor and Council of Peachtree City met on Thursday, December 4, 2014, at City Hall. Mayor Vanessa Fleisch called the meeting to order at 7:00 p.m. Other Council Members attending: Terry Ernst, Eric Imker, Mike King, and Kim Learnard.

## Announcements, Awards, Special Recognition

Sasha Pope was recognized for her help with a pedestrian who was hit by a motorcycle on October 15. Fleisch presented Pope with a Citizen Achievement Award, and Police Sergeant Odilia Bergh and Firefighter/EMT Ashlee Koontz each presented Pope with their department's challenge coin in recognition of Pope's efforts to keep the patient, who received severe head and leg injuries, calm and alert while he was being treated.

#### Consent Agenda

## 1. Consider Budget Adjustment – FY 2015

The budget adjustment was to cover change orders associated with the Station 84 renovation and sewer improvement project.

Ernst moved to approve Consent Agenda Item 1. Consider Budget Adjustment – FY 2015. King seconded. Motion carried unanimously.

#### New Agenda Items

## 12-14-01 Consider Bid for Track Loader Replacement

Public Works Superintendent Scott Hicks said the bid had come in over budget. Two bids were received, and one bid did not meet the bid specifications. Staff recommended Council accept the responsive bid from Yancey Brothers in the amount of \$204,871 for the purchase of a 2015 Caterpillar 953D track loader. Hicks said the 2014 Public Improvement Budget (PIP) had included \$196,000 for one track loader. Funds to cover the difference were budgeted in the 2015 PIP fund.

King moved to approve New Agenda Item 12-14-01 Bid for Track Loader Replacement from Yancey Brothers. Ernst seconded. Motion carried unanimously.

## 12-14-02 Consider Bid for Rubber Tire Loader Replacement

Hicks said four dealers returned bids for the rubber tire loader, and staff recommended Council approve the bid from Flint Equipment Company for \$136,270 for the purchase on one 2015 John Deere 524K rubber tire wheel loader. The amount budgeted in the 2015 PIP fund was \$138,000, so the purchase was \$1,730 under budget.

King moved to approve the bid for the rubber tire loader replacement from Flint Equipment Company. Ernst seconded. Motion carried unanimously.

## 12-14-03 Consider Cancellation of January 1, 2015, Regular Meeting

Learnard moved to cancel the January 1, 2015, regular meeting. King seconded. Motion carried unanimously.

## 12-14-04 Consider Request from Peachtree, LLC/Heritage of Peachtree to Connect to Sanitary Sewer System

City Manager Jim Pennington reported that the assisted living facility was working on its Step 2 annexation request, but there were serious problems with the septic system. Heritage had been in discussions with the Water & Sewerage Authority (WASA) for some time. Heritage had requested that Council allow them to proceed with the connection while the Step 2 annexation application was being compiled.

Learnard asked what the ramifications were of going outside City limits with the sewer. Pennington said it was an unusual request since it was occurring at the same time as the annexation. There were letters from the County and the state regarding the serious issues Heritage had with its septic system.

City Attorney Ted Meeker said there had been a few instances where Council had allowed sewer to extend outside the City limits, using the Mountbrook subdivision off Redwine Road as an example. The sewer line passed within 200 feet of the subdivision, and the connection was allowed. He did not believe allowing sewer outside the City had been done very often since WASA had taken over the system.

Pennington noted that Moira Feeney with Heritage had not been able to attend the meeting and had e-mailed Council about that. Chuck Ogletree, owner of the Peachtree Professional Building, represented Heritage of Peachtree at the meeting.

Fleisch asked if allowing the connection could lead to a proliferation of sewer outside the City limits. Meeker said this connection would be very limited, asking Ogletree where the pump station was located. Ogletree said the pump station was located on his property, and the sewer line would be extended east toward the assisted living center. Meeker noted there was an existing subdivision across the street, and the homes were on septic. Ogletree verified that was correct.

Pennington added there would be changes in the regulations relative to septic systems that would go into effect in January, and there were entities concerned they would not meet the new standards. Ogletree said Heritage was continuing with the Step 2 annexation application, and the reality was they would probably be annexed prior to the completion of the sewer connection.

Meeker added there would be some cost savings for everyone, including WASA, if they moved forward on the connection at this time rather than waiting for the annexation.

Learnard clarified that the request Council was to consider was to give permission for this property to connect with WASA, at their expense.

Ernst moved to approve New Agenda item 12-14-04 Consider Request from Peachtree, LLC/Heritage of Peachtree to Connect to Sanitary Sewer System. King seconded. Motion carried unanimously.

## Council/Staff Topics

Pennington reported staff was able to have the City's alternate dredging locations included in the County's Request for Proposal for the Lake Peachtree dredging. The RFP was on the County's website, and proposals were due back by the end of January.

Pennington noted staff was closer to getting everything needed for the cart paths for The Gates and Somerby areas to get across SR 74. Four paths were needed. One path would come out of

## TITLE 36. LOCAL GOVERNMENT PROVISIONS APPLICABLE TO MUNICIPAL CORPORATIONS ONLY CHAPTER 36. ANNEXATION OF TERRITORY ARTICLE 7. PROCEDURE FOR RESOLVING ANNEXATION DISPUTES

#### 36-36-113. Objection to annexation; grounds and procedures

- (a) The county governing authority may by majority vote to object to the annexation because of a material increase in burden upon the county directly related to any one or more of the following:
  - (1) The proposed change in zoning or land use;
  - (2) Proposed increase in density; and
  - (3) Infrastructure demands related to the proposed change in zoning or land use.
- (b) Delivery of services may not be a basis for a valid objection but may be used in support of a valid objection if directly related to one or more of the subjects enumerated in paragraphs (1), (2), and (3) of subsection (a) of this Code section.
- (c) The objection provided for in subsection (a) of this Code section shall document the nature of the objection specifically providing evidence of any financial impact forming the basis of the objection and shall be delivered to the municipal governing authority by certified mail or statutory overnight delivery to be received not later than the end of the thirtieth calendar day following receipt of the notice provided for in Code Section 36-36-111.
- (d) In order for an objection pursuant to this Code section to be valid, the proposed change in zoning or land use must:
  - (1) Result in:
    - (A) A substantial change in the intensity of the allowable use of the property or a change to a significantly different allowable use; or
    - (B) A use which significantly increases the net cost of infrastructure or significantly diminishes the value or useful life of a capital outlay project, as such term is defined in Code Section 48-8-110, which is furnished by the county to the area to be annexed; and
  - (2) Differ substantially from the existing uses suggested for the property by the county's comprehensive land use or permitted for the property pursuant to the county's zoning ordinance or its land use ordinances.

## 36-36-114. Arbitration panel; composition and membership

- (a) Not later than the fifteenth calendar day following the date the municipal corporation received the first objection provided for in Code Section 36-36-113, an arbitration panel shall be appointed as provided in this Code section.
- (b) The arbitration panel shall be composed of five members to be selected as provided in this subsection. The Department of Community Affairs shall develop three pools of arbitrators, one pool which consists of persons who are currently or within the previous six years have been municipal elected officials, one pool which consists of persons who are currently or within the previous six years have been county elected officials, and one pool which consists of persons with a master's degree or higher in public administration or planning and who are currently employed by an institution of higher learning in this state, other than the Carl Vinson Institute of Government. The pool shall be sufficiently large to ensure as nearly as practicable that no person shall be required to serve on more than two panels in any one calendar year and serve on no more than one panel in any given county in any one calendar year. The department is authorized to coordinate with the Georgia Municipal Association, the Association County Commissioners of Georgia, the Council of Local Governments, and similar organizations in developing and maintaining such pools.
- (c) Upon receiving notice of a disputed annexation, the department shall choose at random four names from the pool of municipal officials, four names from the pool of county officials, and three names from the pool of academics; provided, however, that none of such selections shall include a person who is a resident of the county which has interposed the objection or any municipal corporation located wholly or partially in such county. The municipal corporation shall be permitted to strike or excuse two of the names chosen from the county officials pool; the county shall be permitted to strike or excuse two of the names corporation shall each be permitted to strike or excuse one of the names chosen from the academic pool.
- (d) Prior to being eligible to serve on any of the three pools, persons interested in serving on such panels shall receive joint training in alternative dispute resolution together with zoning and land use training, which may be designed and overseen by the Carl Vinson Institute of Government in conjunction with the Association County Commissioners of Georgia and the Georgia Municipal Association, provided such training is available.
- (e) At the time any person is selected to serve on a panel for any particular annexation dispute, he or she shall sign the following oath: "I do solemnly swear or affirm that I will faithfully perform my duties as an arbitrator in a fair and impartial manner without favor or affection to any party, and that I have not and will not have any ex parte communication regarding the facts and circumstances of the matters to be determined, other than communications with my fellow arbitrators, and will only consider, in making my determination, those matters which may lawfully come before me."

## 36-36-115. Meetings of arbitration panel; duties; findings and recommendations; compensation

- (a) (1) The arbitration panel appointed pursuant to Code Section 36-36-114 shall meet as soon after appointment as practicable and shall receive evidence and argument from the municipal corporation, the county, and the applicant or property owner and shall by majority vote render a decision which shall be binding on all parties to the dispute as provided for in this article not later than the sixtieth day following such appointment. The meetings of the panel in which evidence is submitted or arguments of the parties are made shall be open to the public pursuant to Chapter 14 of Title 50. The panel shall first determine the validity of the grounds for objection as specified in the objection. If an objection involves the financial impact on the county as a result of a change in zoning or land use or the provision of maintenance of infrastructure, the panel shall quantify such impact in terms of cost. As to any objection which the panel has determined to be valid, the panel, in its findings, may establish reasonable zoning, land use, or density conditions applicable to the annexation and propose any reasonable mitigating measures as to an objection pertaining to infrastructure demands.
  - (2) In arriving at its determination, the panel shall consider:
    - (A) The existing comprehensive land use plans of both the county and city;
    - (B) The existing land use patterns in the area of the subject property;
    - (C) The existing zoning patterns in the area of the subject property;
    - (D) Each jurisdiction's provision of infrastructure to the area of the subject property;
    - (E) Whether the county has approved similar changes in intensity or allowable uses on similar developments in other unincorporated areas of the county;
    - (F) Whether the county has approved similar developments in other unincorporated areas of the county which have a similar impact on infrastructure as complained of by the county in its objection; and
    - (G) Whether the infrastructure or capital outlay project which is claimed adversely impacted by the county in its objection was funded by a county-wide tax.
  - (3) The county shall provide supporting evidence that its objection is consistent with its land use plan and the pattern of existing land uses and zonings in the area of the subject property.
  - (4) The county shall bear at least 75 percent of the cost of the arbitration. The panel shall apportion the remaining 25 percent of the cost of the arbitration equitably between the city and the county as the facts of the appeal warrant; provided, however, that if the

panel determines that any party has advanced a position that is substantially frivolous, the costs shall be borne by the party that has advanced such position.

- (5) The reasonable costs of participation in the arbitration process of the property owner or owners whose property is at issue shall be borne by the county and the city in the same proportion as costs are apportioned under paragraph (4) of this subsection.
- (6) The panel shall deliver its findings and recommendations to the parties by certified mail or statutory overnight delivery.
- (b) If the decision of the panel contains zoning, land use, or density conditions, the findings and recommendations of the panel shall be recorded in the deed records of the county with a caption describing the name of the current owner of the property, recording reference of the current owner's acquisition deed and a general description of the property, and plainly showing the expiration date of any restrictions or conditions.
- (c) The arbitration panel shall be dissolved on the tenth day after it renders its findings and recommendations but may be reconvened as provided in Code Section 36-36-116.
- (d) The members of the arbitration panel shall receive the same per diem, expenses, and allowances for their service on the committee as is authorized by law for members of interim legislative study committees.
- (e) If the panel so agrees, any one or more additional annexation disputes which may arise between the parties prior to the panel's initial meeting may be consolidated for the purpose of judicial economy if there are similar issues of location or similar objections raised to such other annexations or the property to be annexed in such other annexations is within 2,500 feet of the subject property.

## 36-36-116. Appeal

The municipal or county governing authority or an applicant for annexation may appeal the decision of the arbitration panel by filing an action in the superior court of the county within ten calendar days from receipt of the panel's findings and recommendations. The sole grounds for appeal shall be to correct errors of fact or of law, the bias or misconduct of an arbitrator, or the panel's abuse of discretion. The superior court shall schedule an expedited appeal and shall render a decision within 20 days from the date of filing. If the court finds that an error of fact or law has been made, that an arbitrator was biased or engaged in misconduct, or that the panel has abused its discretion, the court shall issue such orders governing the proposed annexation as the circumstances may require, including remand to the panel. Any unappealed order shall be binding upon the parties. The appeal shall be assigned to a judge who is not a judge in the circuit in which the county is located.

# 36-36-117. Annexation after conclusion of procedures; remedies for violations of conditions

If the annexation is completed after final resolution of any objection, whether by agreement of the parties, act of the panel, or court order as a result of an appeal, the municipal corporation shall not change the zoning, land use, or density of the annexed property for a period of one year unless such change is made in the service delivery agreement or comprehensive plan and adopted by the affected city and county and all required parties. Following the conclusion of the dispute resolution process outlined in this article, the municipal corporation and an applicant for annexation may either accept the recommendations of the arbitration panel and proceed with the remaining annexation process or abandon the annexation proceeding. A violation of the conditions set forth in this Code section may be enforced thereafter at law or in equity until such conditions have expired as provided in this Code section.


## 36-36-118. Abandonment of proposed annexation; remedies for violations of conditions


If at any time during the proceedings the municipal corporation or applicant abandons the proposed annexation, the county shall not change the zoning, land use, or density affecting the property for a period of one year unless such change is made in the service delivery agreement or comprehensive plan and adopted by the affected city and county and all required parties. A violation of the conditions set forth in this Code section may be enforced thereafter at law or in equity until such period has expired. After final resolution of any objection, whether by agreement of the parties, act of the panel, or any appeal from the panel's decision, the terms of such decision shall remain valid for the one-year period and such annexation may proceed at any time during the one year without any further action or without any further right of objection by the county.

#### **Summary**

As the subject property is currently developed as a pre-school/childcare facility and designated as Office on the Fayette County Future Land Use Plan and will be zoned OI in Peachtree City, there is no change in land use that will result in a substantial change in the intensity of the allowable use of the property or a change to a significantly different allowable use (see State Law below). Staff recommends that the County not object to the annexation. Please note that Fire/EMS and Environmental Management is opposed due to the loss of revenue.




## **Guidelines**

All art panels will be the property of the county government to eliminate liability issues and allow for reuse of the panels.
