## Call to Order

Vice Chairman called the February 8, 2018 Board of Commissioners meeting to order at 6:31 p.m.A quorum of the Board was present, with Chairman Eric Maxwell being absent.

## Invocation and Pledge of Allegiance by Commissioner Charles Oddo

Commissioner Charles Oddo offered the Invocation and led the audience and Board in the Pledge of Allegiance.

#### Acceptance of Agenda

Commissioner Steve Brown moved to approve the agenda with the exception of item #8, which he asked to be moved to the February 22, 2018 Board of Commissioners Meeting. Commissioner Charles D. Rousseau seconded. The motion passed 4-0.

#### **PUBLIC HEARING:**

1. Consideration of Petition No. RDP-014-17 Pulte Homes Company, LLC, request approval of the Revised Development Plan for rezoning 1160-05 to reconfigure the street layout; property located in Land Lots 223, 224, 225 & 226 of the 5th District and fronts on SR 92 North.

Vice – Chairman Ognio recused himself from the discussion of this item, noting his bother has a business relationship with the Petitioner, Pulte Homes Company, LLC.

Commissioner Brown motioned to appoint Commissioner Charles D. Rousseau Chairman for this agenda item. Commissioner Oddo seconded the motion. The motion passed 3-0

Community Development Director Pete Frisina read the rules for public hearings into the record, and briefed the Board on Petition No. RDP-014-17 Pulte Homes Company, LLC, request approval of the Revised Development Plan for

Commissioner Oddo moved to table this item be tabled to the February 22, 2018 BOC Meeting, Vice Chairman Ognio seconded. Motion failed. 2-2

Commissioner Brown moved to compose a letter to Georgia Department of Transportation relating to the roundabout project at Seay Road/ SR 92, telling them that we no longer have an interest in this project due to the cost associated with it, but if possible could we use the funds for another transportation project. Commissioner Rousseau seconded.

Vice-Chairman Ognio noted that based County policies the County Administrator did follow protocol and with the proper authority.

Commissioner Brown moved to ask for public input on what the citizens and staff would like to see in a privatization concept, and bring vision back to the Board for approval. Commissioner Rousseau seconded.

Discussion followed.

Members from the public made comments.

Commissioner Brown restatedmotion to ask for public input on what the citizens and staff would like to see in a privatization concept, and bring vision back to the Board for approval. Motion failed 1-3, with Vice-Chairman Ognio, Commissioner Oddo, and Commissioner Rousseau in opposition.
