# RECOGNITION OF EAGLE SCOUTS BENJAMIN JAMES ELDRIDGE AND JARED PAUL SCHNUTE:

The Board recognized Benjamin James Eldridge and Jared Paul Schnute for their attainment to the rank of Eagle Scout.

Chairman Dunn remarked that when he had gone into the Boy Scouts many years ago he had trouble getting through the tenderfoot scout level. He said he would never have had the tenacity, strength of character and the will to go through everything that these young men had to go through to attain Eagle Scout. He said this was a marvelous program in this Country and many of the Country's leaders started out in scouting. He said there were very few people in scouting who attain this level. He congratulated the young men for their tremendous effort. He asked each scout the project they had chosen for their Eagle Scout project.

Jared Schnute stated that his church needed a playground for toddler age children and he built a playground for his church.

Benjamin Eldridge stated that he had built a prayer labyrinth at Calvin Center in Woolsey. He said a lot of people have enjoyed this and it had helped Calvin attract more people.

Chairman Dunn presented each scout with a framed letter of recognition signed by the Board of Commissioners.

# 2002 GEORGIA D.O.T. LAR31 32-1(113) FOR RESURFACING OF 19 FAYETTE COUNTY ROADS APPROVED:

Public Works Director Lee Hearn presented the Board with the county's comprehensive resurfacing list. He said he had updated it today to include the 19 Fayette County roads under the current year LARP contract. He said in September he had applied to the Georgia D.O.T. for some assistance with the resurfacing of county roads. He said each year the county submits a priority list. He said 63 roads for a total of 36 miles had been submitted in September. He said he had received the list back approved and the funding had been allocated for 19 roads at 7.6 miles. He said last year the county's initial LARP contract was \$182,000 and a supplemental LARP about five or six months later in the amount of \$136,000. He said this year the 7.6 miles came to approximately \$157,000. He said this was substantially reduced from the year before. He said this was due to funding at the State level. He asked for the Board's consideration in authorizing the Chairman to execute the contract so that he could return it to Thomaston for processing. He said he would be glad to answer any questions the Board might have.

Commissioner Frady remarked that the county had in past years been receiving \$720,000 for the LARP program.

Mr. Hearn responded that there were several different mechanisms by which the county could receive funding. He said one was through the LARP. He said typically the county had received \$250,000 to \$300,000 in the five years that he had been associated with the county. He said the county could also ask for a State contract on a case by case basis.

Commissioner Frady asked if the \$720,000 that the county used to received had been almost cut in half.

Mr. Hearn remarked that the LARP contract would be approximately 50% less than what it was the year before. He said his line item in the budget included carry overs as well. He said if a project was not completed it would move forward to the next year.

Chairman Dunn interjected that for the two years that Governor Barnes had been Governor, he had substantially reduced the money each year in the LARP program. He said the first year it was almost 50% and then this year there was another cut almost as much as last year's level. He said the county would continue to fight for these funds. He clarified that the contract he would sign today was only for the unincorporated county's contract with the State.

Mr. Hearn remarked that the priority list was really the county's work in progress and was a working document.

Chairman Dunn asked Mr. Hearn if he knew how much LARP money the three cities had received.

Mr. Hearn replied that he did not know the amounts in their newest contract.

Chairman Dunn said he was aware that the cities were cut a similar percentage as the county was. He said he was signing the contract for the LARP funds for the unincorporated county today.

On motion made by Commissioner Frady, seconded by Commissioner VanLandingham to authorize the Chairman to execute the D.O.T. LARP Contract LAR31 32-1(113) for resurfacing of 19 Fayette County roads. The motion carried 4-0. Commissioner Wells was absent. A copy of the contract, identified as "Attachment No. 1", follows these minutes and is made an official part hereof.
