Welcome to the meeting of your Fayette County Board of Elections. Your participation is appreciated. All regularly scheduled Board meetings are open to the public and are generally held on the 4th Tuesday of each month at 5:00 p.m.

Chairman to Call the Meeting to Order

Chairman Hicks called the July 25, 2017 Board of Elections meeting to order at 5:00 p.m. It was noted that Board Member Aaron Wright was unable to attend the meeting.

Approval of the Agenda

Mr. Lester questioned whether schools would be discussed on the Agenda. Director Jones replied it was part of the discussion under New Business #4.

Mr. Lester moved to approve the Agenda as published. Chairman Hicks seconded the motion. The motion passed 2-0 with Mr. Wright being absent from the meeting.

PUBLIC COMMENTS:

Tony Parrott: Mr. Parrott commented that, even though the consolidation of precincts on county-wide basis would not occur, there were other precincts with polling locations located next to each other that should still be consolidated.

Chairman Hicks replied that the Board would take Mr. Parrott's comments under advisement.

APPROVAL OF MINUTES:

Consideration of staff's request to approve the June 13, 2017 Board of Elections' Meeting Minutes.

Mr. Lester moved to approve the June 13, 2017 Board of Elections' Meeting Minutes. Chairman Hicks seconded the motion. The motion passed 2-0 with Mr. Wright being absent from the meeting.

Mr. Lester moved to approve staff's recommendation to remove registered Fayette County voters from the Elector's List who are registered in the State of Georgia's Secretary of State Voter Registration System as deceased. Chairman Hicks seconded the

motion. The motion passed 2-0 with Mr. Wright being absent from the meeting. A copy of the request, identified as "Attachment 1," follows these minutes and is made an official part hereof.

No one spoke in favor of or in opposition to this matter.

Mr. Lester moved to approve staff's recommendation to remove registered Fayette County voters from the Elector's List who are registered in the State of Georgia's Secretary of State Voter Registration System as felons. The motion passed 2-0 with Mr. Wright being absent from the meeting. A copy of the request, identified as "Attachment 2," follows these minutes and is made an official part hereof.

CONSENT AGENDA:

There were no Consent Agenda items.

OLD BUSINESS:

There were no Old Business items.

NEW BUSINESS:

4. Discussion of the November 7, 2017 elections to be held in Fayette County.

Director Jones recapped the supporting documents provided for New Business #4 as an effort to provide an initial overview of the November 7, 2017 election.

Director Jones reported that on Monday, July 24, the Board of Education had unanimously voted to place an Education Special Purpose Local Option Sales Tax (E-SPLOST) on the November ballot. He reported that this vote of the Board of the Education meant there would be a county-wide election with all 36 precincts. He further explained that since the November election was a combination of city and county elections, there would be many precincts with two lines- one for the county question and the other for city questions. There would also be some precincts where voters would go to one polling location to vote on city questions and would then go to an entirely different polling location to vote on the county question. He added that qualifying would occur in August and there may be some adjustments to his initial analysis based on how qualifying results.

Mr. Jones stated that he and staff had reviewed scenarios on moving out of Braelinn Elementary School and Oak Grove Elementary School in an effort to accommodate a request from the Board of Education not to use those schools. He stated that if the schools were not used the most likely polling location would be The Gathering Place. He stated that The Gathering Place is already used as a polling location and, based on how district combos are assigned, there could be real voter confusion by making the move. He explained that if the schools were not used, then voters from five precincts (Flat Creek, Oak Grove, Braelinn, Whitewater, and Rising Starr) would have to vote at The Gathering Place, resulting in six separate lines. Chairman Hicks pointed out that had consolidation passed, the elections would be held in nine schools. Mr. Jones added that had the Board of Education not voted to have E-SPLOST on the ballot then there would not be the dual-line scenario for this election.

The Board decided, based on the information provided, to remain in the Braelinn Elementary School and Oak Grove Elementary School for the November 7, 2017 election.

Mr. Jones informed the Board that he had already contacted the State of Georgia in order to borrow Express Poll machines since, given the dual election, there would not be enough Express Polls given the current inventory.

Mr. Jones closed by informing the Board that he had discussed poll workers with the State. He explained that the State informed him that its longstanding advice was to provide a poll manager, two assistant poll managers, and clerks for each voter line established. Mr. Jones stated that by following the State's advice the county would have to hire over 72 poll managers, over 144 assistant managers and clerks. He stated that he challenged the State's recommendation and that the State later contacted him stating that, in fact, only one poll manager, two assistant managers, and clerks needed to be hired for each polling location. Mr. Jones stated there would be consideration on how many clerks to hire with the poll managers and assistant poll managers, and that the recommendation would be forthcoming at a future meeting.

The Board did not take a formal vote on any matter during this discussion. A copy of the request, identified as "Attachment 3," follows these minutes and is made an official part hereof.

DIRECTOR'S REPORT:

VRAG Conference: Director Jones reminded the Board that the Voter Registrars Association of Georgia (VRAG) Conference will be held from Sunday, August 13 - Wednesday, August 16, 2017.

Travel to Carroll County / Ethics Training: Director Jones informed the Board that both he and April Crosby would travel to Carroll County, Georgia on August 1, 2017 to attend a regional meeting of the election offices. He added that the meeting would focus on best practices for Ethics filings and requirements.

Candidates Forum at the Fayette County Chamber of Commerce: Director Jones informed the Board that both he and April Crosby would attend a meeting at the Chamber of Commerce on August 11, 2017 to discuss the November 7, 2017 elections with presumptive candidates for office.

Poll Worker Applications: Director Jones notified the Board that poll worker applications are being updated for placement on the county website. He reminded the Board that all newly hired poll workers would mandatorily receive payment through direct deposit and that all returning poll workers would be provided the option of receiving pay through direct deposit. He further mentioned that he and the Human Resources Office would be looking into another matter with a possible recommendation coming at the next Agenda.

National Heights Baptist Church: Director Jones notified the Board that National Heights Baptist Church, which is a current polling location, is closing and immediately reopening as a new church. He stated that he did not know who the new church leadership was, but that it may have implications on this election.

Election Machinery Repaired: Director Jones stated that- with the exception of one piece of machinery which was discovered to have problems- all election machinery has been sent for repair. He added that the machinery is currently being reviewed for compliance by Kennesaw State University, and that this is the first time in approximately two years that all machines have been repaired.

Kennesaw State University: Director Jones reminded the Board the State of Georgia has decided to conclude its partnership with Kennesaw State University in June 2018. He stated that details on the closing and its implications are few at this time.

E-SPLOST Resolution: Director Jones stated that the next Board of Elections meeting would be held on August 29, 2017 and that there would be a Resolution for the Education SPLOST for the Board's adoption.

ATTORNEY'S REPORTS:

Notice of Executive Session: Assistant County Attorney Patrick Stough notified the Board that Executive Session was needed due to threatened litigation.

BOARD MEMBERS REPORTS:

There were no Board Member reports.

O.C.G.A. 21-2-90 reads, in part: "All elections and primaries shall be conducted in each polling place by a board consisting of a chief manager, who shall be chairperson of such board, and two assistant managers assisted by clerks. The managers of each polling place shall be appointed by the superintendent. . . When such lists are submitted to the appropriate office, the superintendent, insofar as practicable, shall make appointments so that there shall be equal representation on such boards for the political parties involved in such elections or primaries. The superintendent shall make each appointment by entering an order which shall remain on record in the appropriate office and shall make such order available for public inspection upon request. The order shall include the name and address of the appointee, his or her title, and a designation of the precinct and primary or election in which he or she is to serve.

Cancellation of an Election

If only one candidate qualifies for an office and that office is the only election being held, that candidate is deemed to be the winner and the election is cancelled.

O.C.G.A. § 21-2-285

- (j) Any other provision of law to the contrary notwithstanding, in the event there is no opposed candidate in a precinct in a general or special municipal election, no election shall be held in such precinct unless a write-in candidate has qualified as provided by law or unless there are issues to be submitted to the electorate within a precinct.
- (k) When, pursuant to subsection (j) of this Code section, no election is to be conducted, the municipality shall provide notice reasonably calculated to inform the affected electorate that no election is to be conducted. Each such unopposed candidate shall be deemed to have voted for himself or herself. The superintendent shall certify such unopposed candidate as elected in the same manner as he or she certifies other candidates pursuant to Code Section § 21-2-502.

Note: Write-In Candidates for office must be qualified per O.C.G.A § 21-2-133. The deadline to qualify as a write-in candidate expires on Friday, September 1, 2017.

As of close of qualifying on August 25, 2017, the following municipal offices had qualified, unopposed candidates:

Fayetteville Councilman Posts 3 & 5

Peachtree City Councilman Post 4

Tyrone Councilman Post 4

Brooks Mayor & Councilman Post 1

Unless there is a qualified write-in candidate for any of these positions by end of business on September 1, 2017, O.C.G.A. §21-2-285(j) will go into effect.

Municipal precint ballots will show the contested offices, but will not show unopposed candidates. All ballots for all precincts will have the Board of Education's Education Special Purpose Local Option Sales Tax (E-SPLOST) question.

KENNESAW STATE UNIVERSITY DEADLINE

Kennesaw State University has set a deadline of September 1, 2017 as the last day to submit ballot information for the November 7, 2017 ballot.

A PROJECTION FOR THE NOVEMBER 7, 2017 ELECTION PROCESS

There is an established pattern for elections. In even-numbered years the pattern is that county, state, and federal level positions are set-up for election. In odd-numbered years, elections are scheduled for municipal offices.

This pattern does not always hold due to factors such as resignations, passing away while in office, etc.

Kennesaw State University is employed by almost all Georgia Counties to build ballots for the elections. Their ballot building process follows the pattern and databases have been created in accordance to the pattern. When the pattern is not followed and there is a mixture of county, state, or federal elections being held at the same time as municipal elections, Kennesaw State University has to create two separate databases. This translates into the county essentially holding two separate elections at the same time.

Fayette County last experienced two elections at the same time with the November 2013 election.

Since there are two elections occurring concurrently, each municipal polling location will have two linesone for the county election and one for the municipal election. This involves two separate groups of machines for at county-city polling locations.

Those precincts that are strictly within a county and have no city voters will have only one line for the county election only.

One poll manager and two assistant managers will be appointed for each precinct. One clerk will be provided to county-only precincts. Two to three clerks will be provided to county-city precincts.

Since the County has split precincts, there is also the possibility that some voters will vote at one location for city matters and at a different location for the county question. The following will illustrate how the potential precincts may be configured for the vote.

COUNTY ONLY PRECINCTS

County only precincts have no municipal involvement. These precincts will have only one line with one set of machines for the county question.

Precinct #3- Europe (2,843 voters) Precinct #6- Flint (1,405 voters)

Precinct #7- Hopeful (1,800 voters) Precinct #13- Starr's Mill (3,186 voters)

Precinct #23- Kenwood (892 voters) Precinct #25- Harps Crossing (1,507 voters)

Precinct #28- Oak Ridge (1,919 voters) Precinct #36- Antioch (1,693 voters)

COUNTY / CITY PRECINCTS

County / City precincts are those precincts where voters residing in the precinct vote at one location. These voters will have two lines: one for the county question and the other line for their respective municipal question. The precincts under this category are:

Precinct #2- Brooks (2,048 voters)

Precinct #5- Fayetteville West (1,601 voters)

Precinct #9- Rareover (2,599 voters) Precinct #11- Shakerag East (1,385 voters)

Precinct #12- Shakerag West (1,179 voters) Precinct #15- Woolsey (2,248 voters)

Precinct #16- McIntosh (2,968 voters) Precinct #17- Oak Grove (1,243 voters)

Precinct #18- Kedron (3,119 voters) Precinct #19- Aberdeen (1,564 voters)

Precinct #20- Windgate (906 voters)* Precinct #21- Flat Creek (1,816 voters)

Precinct #22- Braelinn (1,763 voters) Precinct #31- Fielding Ridge (3,232 voters)

Precinct #32- Willowbend (1,750 voters) Precinct #33- Camp Creek (1,744 voters)*

Precinct #35- Spring Hill (2,697 voters)

Note: Precinct #15- Woolsey may have only a county question- with only one line- if there is no write-in candidate for a Woolsey office.

Note: Precinct #20 and Precinct #33 utilize Evergreen Church as its polling location. Since there are two precincts housed in one polling location, there will be a total of four lines in the church.

Two lines are dedicated to Precinct #20's county-city questions and two lines are dedicated to Precinct #33's county-city questions.

SPLIT PRECINCTS

Fayette County has ten split precincts. A split precinct means that the voter would have to vote for city matters at one physical location and then travel to a separate physical location to vote on the county matter. Furthermore, the Whitewater and Dogwood precincts are split in three separate ways. The following details the splits:

Precinct #1- Blackrock There are 2,398 voters assigned to Blackrock. Of these voters 858 are

county voters and 1,540 are city voters. All 2,398 have to vote at

Fayetteville Christian Church for county matters and only 1,540 will vote

at Lafayette Educational Center for municipal matters only.

Precinct #4- Fayetteville East There are 1,754 voters assigned to Fayetteville East. All voters must

vote at Fayetteville United Methodist Church for county matters and

1,542 voters can vote at the Lafayette Educational Center for municipal

matters only.

Precinct #8- Morning Creek There are 3,003 voters assigned to Morning Creek. All voters must vote

at New Hope Baptist Church- North Campus for county matters and 287 can vote at Lafayette Educational Center for municipal matters only.

Precinct #10- Sandy Creek There are 3,774 voters assigned to Sandy Creek. All voters most vote at

Hopewell United Methodist Church for county matters and 1,832 can

vote at the Tyrone Public Library for municipal matters only.

Precinct #14- Whitewater There are 3,227 voters assigned to Whitewater. All voters must vote at

Rolling Hills Baptist Church for their county question. There are 17 Peachtree City residents who will have to vote at Braelinn Elementary School for the municipal questions. There are also 275 City of

Fayetteville voters who will have to vote at the Fayette County Library

for municipal questions.

Precinct #24- Banks There are 1,470 voters assigned to Banks. All voters must vote at

Berachah Bible Church for county matters. Currently there are no city voters assigned to Banks, however, there is an outside chance- if a voter registers for the city- that voter would vote at the Lafayette Educational

Center for city questions.

Precinct #26- Willow Pond There are 2,456 voters assigned to Willow Pond. All voters must vote at

The Pinecrest Church (formerly National Heights Baptist Church) for county matters and 1,464 must vote at the Fayette County Library for

municipal matters.

Precinct #27- Dogwood There are 2,474 voters assigned to Dogwood. All voters must vote at

Grace Evangelical Church for county questions. There are 651 Town of Tyrone voters who must vote at the Tyrone Public Library for the municipal question. There are 5 City of Fayetteville residents vote at

the Lafayette Educational Center for municipal matters.

Precinct #29- Jeff Davis There are 2,446 voters assigned to Jeff Davis. All voters must vote at

Fayetteville First Baptist Church for county matters and 2,320 must vote

at the Fayette County Library for municipal matters.

Precinct #30- Murphy There are 2,802 voters assigned to Murphy. All voters must vote at

Outreach International Center for county matters and 680 must vote at

the Fayette County Library for municipal matters.

Precinct #34- Rising Starr There are 3,249 voters assigned to Rising Starr. All voters must vote at

the Rising Starr School Auditorium for county matters and 1,827 voters

must vote at Braelinn Elementary School for municipal matters.

In total there are 41,350 municipal voters across Fayette County. There are 77,808 active voters (county / city combined) currently in Fayette County.

SCHOOLS

Fayette County currently uses four schools as voting precincts: Lafayette Educational Center, Rising Starr Auditorium, Braelinn Elementary School and Oak Grove Elementary School.

The Board of Elections, at its July 25, 2017 meeting, decided to remain in all four schools for this election.

ELECTION MACHINES

Staff anticipates these elections, even combined, will be relatively small elections in terms of voter turnout.

Given the two-lines per precinct scenario as described, staff anticipates having enough DRE voting machines to accommodate this election.

Fayette County does not have enough Express Poll machines to accommodate the election. Staff was informed by KSU that the Secretary of State's Office has additional Express Polls that can be borrowed from the state for this election. Based on that knowledge, staff has reserved the needed Express Polls from the state. However, there are not enough scanners. The election can be held, but checking in voters will be a slower process since it will be done manually.

STAFFING

Fayette County has 36 precincts that have to be opened for this election. This requires hiring 36 poll managers and 72 assistant poll managers.

A clerk will be provided for each precinct that only has a county question.

Poll managers are requesting two to three clerks to be provided for those precincts with two lines.

Staff requests flexibility in appointing up to three clerks at precincts based on perceived or actual need.

BACKGROUND / HISTORY / DETAILS

The current bylaws of the Fayette County Board of Elections and Voter Registration was adopted on January 22, 2008.

Amended by-laws were discussed periodically during the first half of calendar year 2016, however, the minutes do not reflect that the amended minutes were ever adopted.

The amended by-laws are provided for the Board's consideration and adoption.

Staff has no objection to the bylaws and recommends the adoption.

SPECIFIC ACTION / DIRECTION SOUGHT

Adoption of the Fayette County Board of Elections By-laws as amended on June 28, 2016.

BYLAWS

FAYETTE COUNTY BOARD OF ELECTIONS AND VOTER REGISTRATION

ADOPTED IN SESSION JANUARY 22, 2008

AMENDED JUNE 28, 2016

I. NAME

The name of this Board shall be the Fayette County Board of Elections and Voter Registration, hereinafter referred to as the "Board."

II. PURPOSE

The purpose of this Board is:

- 1) To protect the integrity of all elections conducted by the Board.
- 2) To conduct elections in a legal, ethical, and non-partisan manner with an environment of honesty, openness, impartiality, and integrity, keeping in mind the public trust and interest of all voters in Fayette County. The Board or its members should avoid any action which might result in, or create the appearance of, affecting adversely the confidence of the public in the integrity of any election.

III. CONFLICT OF INTEREST

Board members should not engage in political activity such as campaigning for any candidate on a Fayette County ballot (whether as a volunteer or a paid position) or ballot question, writing letters to the editor, or participating in discussion or comments regarding candidates or candidates' activities. Board members should conduct themselves in an objective, detached and non-partisan manner while conducting the business of the Board. Board members may not speak at public meetings in support of or in opposition to an issue or candidate on a Fayette County ballot. The Code of Ethics for the Fayette County Government in effect as of the adoption and/or readoption of these Bylaws governs the affairs and activities of the Board and is incorporated by reference into these Bylaws.

IV. ORGANIZATION OF THE BOARD

The Board is empowered to organize itself, determine its procedural rules and regulations, adopt bylaws, specify functions and duties of its employees, and otherwise take such actions as are appropriate to the management of the affairs committed to its supervision; provided, however, that no such action shall conflict with state law. The Chairman of the Board shall be the Chief Executive Officer and shall generally supervise, direct, and control the administration of the affairs of the Board pursuant to law and duly adopted resolutions of the

Board as prescribed by law. The Chairman will be elected among the Board members at the February meeting of each even numbered year to serve for a term of two years.

The Board shall enter into its minutes any directives governing the execution of matters within its jurisdiction. The Board shall hold regular monthly meetings at the Elections Office, unless cancelled for lack of business. Any special called meetings shall be held in accordance with the provisions of state law. The Board shall maintain a written record of policy decisions that shall be amended to include additions or deletions. Meetings shall be conducted, insofar as practicable, in accordance with Robert's Rules of Order and Minutes shall be kept of all meetings and shall reflect the votes of each member upon matters voted upon. The Board shall keep correct and complete books and records of account and shall also store the Minutes of all meetings at the Elections Office. Individual Board members may not issue directives to administrative staff or poll workers. All directives to staff and poll workers must be at the behest of the Chairman of the Board and/or the entire Board, acting in its official capacity.

The Board shall be authorized to appoint an Elections Superintendent and to employ any other employees deemed appropriate to manage the matters of the elections and voter registration.

The Board shall be responsible for the selection, appointment and training of poll workers in elections.

V. INVESTIGATIONS

The Board may conduct investigations of irregularities in voting practices, voter registrations, and suspected violations of election laws. Any such investigation shall be conducted in strict compliance with Georgia law and the results shall be made available to the proper law enforcement agencies.

VI. CONFLICT WITH STATE ELECTIONS BOARD RULES

These Bylaws should not be in conflict with the rules of the State Election Board. In case of a conflict, the rules of the State Election Board shall control.

VII. PENALTIES FOR VIOLATION OF BYLAWS

In its discretion, if the Board determines that there has been a violation of these Bylaws, it may impose penalties for said violations(s), including censure and revocation of monthly pay for the Board member. Additional penalties can be imposed by the Board at its discretion.

VIII. AMENDMENTS TO BYLAWS

These Bylaws may be amended by majority vote of the Board at any meeting of the Board, provided that seven (7) days' notice of the intention to amend said Bylaws has been received by Board members, said notice setting forth in detail the proposed amendment. Any

RESOLUTION OF THE BOARD OF EDUCATION

ADOPTED ON JULY 24, 2017

A RESOLUTION OF THE BOARD OF EDUCATION OF THE FAYETTE COUNTY SCHOOL DISTRICT TO REGULATE AND PROVIDE FOR THE CALLING OF AN ELECTION TO DETERMINE THE CONTINUATION OF A ONE PERCENT SALES AND USE TAX; AND FOR OTHER PURPOSES

A RESOLUTION OF THE BOARD OF EDUCATION OF THE FAYETTE COUNTY SCHOOL DISTRICT TO REGULATE AND PROVIDE FOR THE CALLING OF AN ELECTION TO DETERMINE THE CONTINUATION OF A ONE PERCENT SALES AND USE TAX; AND FOR OTHER PURPOSES.

WHEREAS, Article VIII, Section VI, Paragraph IV of the Constitution of the State of Georgia (the "Amendment") and Article 3 of Chapter 8 of Title 48 of the Official Code of Georgia Annotated, as amended (the "Act") authorize the imposition of a one percent sales and use tax for the purpose of financing certain capital outlay projects for educational purposes and retiring existing general obligation debt previously incurred for projects for educational purposes (the "Sales and Use Tax"); and

WHEREAS, the Fayette County School District (the "School District") is currently collecting the Sales and Use Tax, and the Sales and Use Tax will expire on or before March 31, 2019; and

WHEREAS, the Board of Education (the "Board") of the School District, which is charged with the duties of contracting debts and managing the affairs of the School District, has determined that it is in the best interest of the citizens of the School District that the Sales and Use Tax be continued in the School District for a period of time not to exceed 20 calendar quarters to raise not more than \$145,000,000 for the purposes of funding certain capital outlay projects for educational purposes and retiring existing general obligation debt previously incurred for projects for educational purposes; and

WHEREAS, there are no independent school districts within Fayette County; and

WHEREAS, it is necessary to submit to the qualified voters of the School District the question of whether or not the Sales and Use Tax should be continued.

NOW, THEREFORE, BE IT RESOLVED by the Board, and it is hereby resolved by authority of the same as follows:

- Section 1. <u>Call for Election</u>. The Fayette County Board of Elections (the "Board of Elections") is hereby requested to call an election on November 7, 2017 (the "Election") for the purpose of submitting to the qualified voters of the School District the question set forth in the notice of election (the "Notice") attached hereto as Exhibit A. The Election shall be held in all of the voting precincts in the School District and shall be conducted in accordance with the election laws of the State of Georgia.
- Section 2. <u>Form of Ballot</u>. The ballot to be used in the Election shall be substantially in the form set forth in the Notice.
- Section 3. <u>Authorization of Sales and Use Tax</u>. In order to finance the capital outlay projects for educational purposes listed in the ballot (the "Projects") and retiring existing general obligation debt previously incurred for projects for educational purposes listed in the ballot

(the "Prior Debt"), the Sales and Use Tax is hereby authorized to be levied and collected within Fayette County as provided in the Amendment and the Act. As required by the Amendment and the Act:

- (a) the proceeds of the Sales and Use Tax will be used to (i) fund the Projects, (ii) retire a portion of the Prior Debt and (iii) pay interest on the Debt (hereinafter defined);
- (b) the maximum cost of the Projects, including interest on the Debt, to be funded with the Sales and Use Tax proceeds will not exceed \$145,000,000 and the maximum amount of principal of and interest on the Prior Debt that may be retired with the Sales and Use Tax proceeds will not exceed \$10,000,000; and
- (c) the maximum period of time that the Sales and Use Tax shall be collected will not exceed 20 consecutive calendar quarters commencing upon the expiration of the current tax.

Section 4. <u>Debt Terms</u>. Assuming that the imposition of such Sales and Use Tax is approved by the voters of the School District in the Election, the School District is hereby authorized to, but not obligated to, issue general obligation debt (the "Debt"), in whole or in part and in one or more series, secured by the proceeds of such Sales and Use Tax, in a maximum aggregate principal amount of \$25,000,000. The proceeds of the Debt, if issued, shall be used to fund the Projects, capitalized interest and the costs of issuing the Debt. The Debt shall bear interest at rates not to exceed 6% from its date of issuance or from such other date as may be designated by the School District prior to the issuance of the Debt. The actual rate or rates shall be determined in a supplemental resolution to be adopted by the School District prior to the issuance of the Debt. The maximum amount of principal to be paid in each year (serially or, at the option of the Board, by mandatory sinking fund redemption) during the life of such Debt shall be as follows:

Sales and Use Tax proceeds received in any year shall first be used to pay the debt service requirements on the Debt for any such year before proceeds are used for the Projects not funded with Debt proceeds.

Section 5. <u>State Funds</u>. To the extent possible, the School District intends to combine its available State funds with revenues from the Sales and Use Tax and other local funds to finance the Projects.

Section 6. <u>Publication of Call and Notice</u>. The Board of Elections is hereby authorized and requested to publish a call of the Election (the "Call") in the newspaper in which

Sheriff's advertisements for Fayette County are published (the "Legal Organ") as soon as practicable. The Call shall be substantially in the form attached hereto as Exhibit B. The Board of Elections is hereby authorized and requested to publish the Notice in the Legal Organ once a week for four weeks immediately preceding the date of the Election.

- Section 7. Property Tax Levy. Should the Debt be authorized by the requisite number of qualified voters, the Board shall direct the Board of Commissioners of Fayette County to levy a tax upon all property subject to taxation for general obligation school bond purposes within Fayette County sufficient in amount to pay the principal of and interest on the Debt as the same becomes due. Such ad valorem property tax shall, however, only be collected if the proceeds of the Sales and Use Tax are insufficient to pay the principal of and interest on the Debt as the same become due.
- Section 8. <u>Brochures and Advertisements</u>. Any brochures, listings, or other advertisements issued by the Board or by any other person, firm, corporation or association with the knowledge and consent of the Board, shall be deemed to be a statement of intention of the Board concerning the use of the proceeds of the Debt, and such statement of intention shall be binding upon the Board in the expenditure of such Debt or interest received from such Debt to the extent provided in Section 36-82-1 of the Official Code of Georgia Annotated.
- Section 9. <u>Notice to Board of Elections</u>. The Secretary of the Board is hereby authorized and directed to deliver a copy of this resolution to the Board of Elections, with a request that the Board of Elections call the Election.
- Section 10. <u>Bond Audit Waiver.</u> The Board waives the independent performance audit or performance review referred to in O.C.G.A. §36-82-100.
- Section 11. <u>Further Authority</u>. The proper officers, employees and agents of the School District are hereby authorized to take any and all further actions as may be required in connection with the issuance of the Bonds, the imposition of the sales and use tax and the acquisition, construction and equipping of the Projects described above.
- Section 12. <u>Conflicting Resolutions</u>. All resolutions that conflict in whole or in part with this Resolution are hereby repealed.
- Section 13. <u>Effective Date</u>. This Resolution shall take effect immediately upon its adoption.
