Flood Hazard Area of Zone 'A' with Future 100 Year at the up-stream cross-section (Future elevation = 873.68/Existing elevation= 873.61) as per the 2013 Fayette County Flood Study. The house and property are located in Zone 'X'. The AC units were installed on pads and located at the side of building.
