2015 Fire / EMS Training— 31,213 Hours

In 2015 the department conducted 1 recruit class for 12 new cadets and began a training program for part-time firefighters. Each of these recruit firefighters underwent 480 hours of rigorous mental and physical challenges over a 12 week period. All recruits then successfully completed the State and National Professional Qualifications Firefighter Level 1 and 2 testing process.

Emergency Management Agency



In 2015 Emergency Management opened and dedicated the new Emergency Operations Center and completed the federally required Hazard Mitigation plan. The update continued to keep Fayette County in federal compliance and allow the county and municipalities to be eligible for grants that reduced the effects of disasters in our community. Emergency Management coordinated the relief efforts of two weather events that affected the citizens of Fayette County. Whispering Pines Mobile Home park residents fell victim to a micro-burst weather event that destroyed 11 homes, damaged many others and displaced many residents. Additionally, Emergency Management responded and coordinated efforts for a flood event in late 2015 where 14 inches of rain fell in 10 days. The flood recovery efforts to damaged infrastructure continue.



Bureau of Fire Prevention

The Fire Marshal's Office places a high priority on fire prevention. The most effective method of fire prevention is public education. In 2015 the Fire Marshal's Office conducted fire prevention for all 3rd grade students in the Fayette County Schools within the unincorporated county. This event is held in the month of October of each year and this program contacted approximately 400 children. The department also provides public education to many senior organizations and fire extinguisher training course to the public and business owners. The Bureau also takes time to educate building owners and tenants while conducting inspections. This helps to gain voluntary compliance, as well as limit the number of repeat inspections.
