S4	4-2A All food items must be kept/ stored covered at all times when not actively in use. Container of dried chiles uncovered under prep table near handsink in kitchen.
S12	12 All wiping cloths must be stored in a sanitizer solution of the proper concentration. Chlorine sanitizer at bar 50 ppm.
S14	14B All dinnerware/ serviceware must be stored inverted or covered to protect from possible contamination. Black salsa containers stored upright at wait station next to chip dispensing unit.
S15	15C Additional cleaning is needed of box fan above handsink in kitchen due to some dust build-up.
