TITLE: Sr. Financial Analyst

DEPARTMENT: Finance, Fayette County

JOB SUMMARY: This position is responsible for the accounting and analytical functions related to Bank transactions, general ledger close, payroll, property and casualty insurance, year-end audit and financial reporting.

## MAJOR DUTIES:

- o Participates with Purchasing in analyzing competing annual proposals for property and casualty insurance and recommends insurance carrier; insures that invoices received from the insurance carrier are in agreement with the existing policy; newly acquired equipment or other assets are added to insurance schedules and retired assets are deleted.
- o Prepares, processes, and posts all necessary transactions, journal entries, and maintenance; reviews general ledger activity; provides monthly reconciliations for the activity of banking and payroll.
- o Processes monthly and year-end close of general ledger activity and prepares all necessary schedules for the annual audit and CAFR.
- Produces and submits on a timely basis quarterly and year-end reports such as 941s,W-2s, W-3, as required by various agencies.
- Participates in the budget process; prepares necessary schedules and reports used in budgeting.
- o Completes various research projects as assigned.
- o Performs other related duties as assigned.

## KNOWLEDGE REQUIRED BY THE POSITION:

- o Knowledge of risk management and insurance concepts and terminology.
- o Knowledge of governmental accounting practices.
- o Knowledge of governmental budget development and management procedures.
- o Knowledge of computers and job related software programs.
- o Skill in public and interpersonal relations.
- o Skill in researching and preparing reports.

o Skill in oral and written communication.

SUPERVISORY CONTROLS: The Assistant Chief Financial Officer assigns work in terms of very general instructions. The supervisor spot-checks completed work for compliance with procedures and the nature and propriety of the final results.

GUIDELINES: Guidelines include county personnel policies, the county code, Generally Accepted Accounting Principles, accounting and auditing standards, Government Finance Officers Association recommendations, and state laws and regulations. These guidelines require judgment, selection, and interpretation in application.

COMPLEXITY: The work consists of varied accounting and financial duties. Strict regulations and the need for accuracy contribute to the complexity of the position.

SCOPE AND EFFECT: The purpose of this position is to monitor accounting results. Success in this position contributes to the accuracy of county financial records.

PERSONAL CONTACTS: Contacts are typically with co-workers, outside auditors, vendors, insurance agents, state officials, and members of the general public.

PURPOSE OF CONTACTS: Contacts are typically to give or exchange information, resolve problems, and provide services.

PHYSICAL DEMANDS: The work is typically performed while sitting at a desk or table. The employee occasionally lifts light objects.

WORK ENVIRONMENT: The work is typically performed in an office.

SUPERVISORY AND MANAGEMENT RESPONSIBILITY: None.

SPECIAL CERTIFICATIONS AND LICENSES: Possession of a valid State of Georgia driver's license (Class C) and a satisfactory Motor Vehicle Record (MVR) in compliance with County Safety and Loss Control Guidelines. Completion of the State of Georgia Department of Transportation Defensive Driving Course and/or Emergency Vehicle Operation Certification within twelve (12) months of employment.
