DEPARTMENT: Probate Court, Fayette County

JOB SUMMARY: This position performs clerical duties in support of the work of the Probate Court.

MAJOR DUTIES:

- o Records proceedings; makes copies and notates computer and paper indexes.
- o Issues and records marriage licenses; mails marriage certificates.
- o Accepts passport applications and forwards to Passport Processing Center; maintains related records.
- o Greets visitors and provides information and assistance; accepts petitions; issues certified copies of birth and death certificates; accepts firearm permit applications.
- o Answers telephones; provides information and assistance; takes messages; forwards calls.
- o Transports items to Administrative Complex, Post Office, and publishing company; picks up and distributes mail.
- o Locates records for title searchers and genealogists.
- o Copies birth and death certificates to index cards.
- o Makes photocopies of petitions.
- o Runs background checks for gun permits and guardianships.
- o Performs other related duties as assigned.

KNOWLEDGE REQUIRED BY THE POSITION:

- o Knowledge of office procedures and policies.
- o Knowledge of the principles and practices of records management.
- o Knowledge of computers and job related software programs.
- o Knowledge of Probate Court rules and regulations.

- o Skill in public and interpersonal relations.
- o Skill in oral and written communication.

SUPERVISORY CONTROLS: The Clerk of Probate Court assigns work in terms of general instructions. The supervisor spot-checks completed work for compliance with procedures, accuracy, and the nature and propriety of the final results.

GUIDELINES: Guidelines include the Official Code of Georgia and office procedures. These guidelines are generally clear and specific, but may require some interpretation in application.

COMPLEXITY: The work consists of related clerical duties. Strict regulations and deadlines contribute to the complexity of the position.

SCOPE AND EFFECT: The purpose of this position is to provide clerical support for the work of the Probate Court. Success in this position contributes to the efficiency and effectiveness of court operations.

PERSONAL CONTACTS: Contacts are typically with co-workers, the general public, and court personnel.

PURPOSE OF CONTACTS: Contacts are typically to give or exchange information; resolve problems; or provide services.

PHYSICAL DEMANDS: The work is typically performed while sitting at a desk or table or while intermittently sitting, standing, or stooping. The employee occasionally lifts light objects and climbs ladders.

WORK ENVIRONMENT: The work is typically performed in an office.

SUPERVISORY AND MANAGEMENT RESPONSIBILITY: None.

SPECIAL CERTIFICATIONS AND LICENSES: Possession of a valid State of Georgia driver's license (Class C) and a satisfactory Motor Vehicle Record (MVR) in compliance with County Safety and Loss Control Guidelines. Completion of the State of Georgia Department of Transportation Defensive Driving Course and/or Emergency Vehicle Operation Certification within twelve (12) months of employment.
