TITLE: Sign Technician

DEPARTMENT: Road, Fayette County

JOB SUMMARY: This position is responsible for the installation, repair, and maintenance of county road signs.

MAJOR DUTIES:

- o Repairs road signs.
- o Operates sign design computer software and the sign press.
- o Removes animal carcasses from roadway.
- o Repairs mail boxes.
- o Removes graffiti from roads and signs.
- o Installs RPM markers and stop bars.
- o Delivers signs to work stations and other departments.
- o Performs other related duties as assigned.

KNOWLEDGE REQUIRED BY THE POSITION:

- o Knowledge of the principles and practices of road sign installation, repair, and maintenance.
- o Knowledge of safety principles and practices.
- o Knowledge of Manual of Uniform Traffic Control Devices standards.
- o Skill in the operation of job related equipment and hand tools.
- o Skill in the operation of as assigned vehicle.
- o Skill in oral and written communication.

SUPERVISORY CONTROLS: The Road Superintendent assigns work in terms of general instructions. The supervisor spot-checks completed work for compliance with procedures, accuracy, and the nature and propriety of the final results.

GUIDELINES: Guidelines include county policies and procedures, the Manual of Uniform Traffic Control Devices, and OSHA regulations. These guidelines are generally clear and specific, but may require some interpretation in application.

COMPLEXITY: The work consists of related technical duties in the installation, repair, and maintenance of road signs.. Heavy traffic and inclement weather contribute to the complexity of the position.

SCOPE AND EFFECT: The purpose of this position is to install, repair, and maintains road signs. Success in this position contributes to the safety of county road ways.

PERSONAL CONTACTS: Contacts are typically with co-workers and members of the general public.

PURPOSE OF CONTACTS: Contacts are typically to give or exchange information; resolve problems; and provide services.

PHYSICAL DEMANDS: The work is typically performed while intermittently sitting, standing, walking, bending, crouching, or stooping. The employee occasionally lifts light and heavy objects and uses tools or equipment requiring a high degree of dexterity.

WORK ENVIRONMENT: The work is typically performed outdoors. The employee is exposed to noise, dust, dirt, grease, machinery with moving parts, and occasional cold or inclement weather. The work requires the use of protective devices such as masks, goggles, or gloves.

SUPERVISORY AND MANAGEMENT RESPONSIBILITY: None.

SPECIAL CERTIFICATIONS AND LICENSES: Possession of a valid State of Georgia driver's license (Class C) and a satisfactory Motor Vehicle Record (MVR) in compliance with County Safety and Loss Control Guidelines. Completion of the State of Georgia Department of Transportation Defensive Driving Course and/or Emergency Vehicle Operation Certification within twelve (12) months of employment.
