- o Skill in interpreting complex information and in conveying it to others in a accurate, complete, and understandable manner.

PERSONAL CONTACTS: Contacts are typically with co-workers, victims, the general public, and court personnel.

PURPOSE OF CONTACTS: Contacts are typically to give or exchange information; resolve problems; or provide services.

PHYSICAL DEMANDS: The work is typically performed while sitting at a desk or table or while intermittently sitting, standing, bending, crouching, or stooping. The employee occasionally lifts light objects and climbs ladders.

WORK ENVIRONMENT: The work is typically performed in an office.
