TITLE: Tag Clerk

DEPARTMENT: Tax Commissioner, Fayette County

JOB SUMMARY: This position is responsible for participating in the issuance of tags and decals. An incumbent in this position may be designated "Senior Tag Clerk."

MAJOR DUTIES:

- o Collects county revenues and records data.
- o Issues various decals and license plates.
- o Processes title applications.
- o Balances and reconciles end-of-day collections.
- o Attends seminars and training classes.
- o Obtains sale documents for out of state vehicle purchases and calculates sales tax.
- o Prepares and issues disable parking permits and plates.
- o Collects and records data for emission inspections.
- o Contacts insurance companies to obtain verification of insurance.
- o Assists customer by phone and in person.
- o Performs other duties as assigned.

KNOWLEDGE REQUIRED BY THE POSITION:

- o Knowledge of state laws and regulations regulating the issuance of automobile tags and the collection of ad valorem tax.
- o Knowledge of computers and job related software programs.
- o Skill in interpreting complex information and in conveying it to others in a accurate, complete, and understandable manner.
- o Skill in public and interpersonal relations.
- o Skill in oral and written communication.

SUPERVISORY CONTROLS: The Tag Agent Supervisor assigns work in terms of somewhat general instructions. The supervisor spot-checks completed work for compliance with instructions and established procedures, accuracy, and the nature and propriety of the final results.

GUIDELINES: Guidelines include county policies and procedures, Georgia Department of Revenue Rules and Regulations, and the Official Code of Georgia, Annotated. These guidelines are generally clear and specific, but may require some interpretation in application.

COMPLEXITY: The work consists of related tax collection duties. The need for accuracy contributes to the complexity of the position.

SCOPE AND EFFECT: The purpose of this position is to participate in the issuance of automobile tags and the collection of ad valorem taxes. Success in this position contributes to the efficiency of tax collection activities.

PERSONAL CONTACTS: Contacts are typically with co-workers, members of the general public, insurance company representatives, and recipients of direct services.

PURPOSE OF CONTACTS: Contacts are typically to give or exchange information, resolve problems, and provide services.

PHYSICAL DEMANDS: The work is typically performed while sitting at a desk or table or intermittently sitting, standing, or stooping. The employee frequently lifts light objects.

WORK ENVIRONMENT: The work is typically performed in an office.

SUPERVISORY AND MANAGEMENT RESPONSIBILITY: None.

SPECIAL CERTIFICATIONS AND LICENSES: Possession of a valid State of Georgia driver's license (Class C) and a satisfactory Motor Vehicle Record (MVR) in compliance with County Safety and Loss Control Guidelines. Completion of the State of Georgia Department of Transportation Defensive Driving Course and/or Emergency Vehicle Operation Certification within twelve (12) months of employment.

ADA COMPLIANCE: Fayette County is an Equal Opportunity Employer. ADA requires the County to provide reasonable accommodations to qualified individuals with disabilities. Prospective and current employees are invited to discuss accommodations.
