TITLE: Wetlands Caretaker WTP/7

DEPARTMENT: Water Treatment Plant, Fayette County

JOB SUMMARY: This position is responsible for the maintenance and repair of plant related wetlands.

MAJOR DUTIES:

- o Maintains dams; prepares dams for annual state inspection; repairs pipes; flushes wet well; cuts trees and underbrush; checks gates, locks, and fences; paints over graffiti; picks up garbage.
- o Maintains tank sites, well sites, and parks; cuts grass and trims weeds; removes trash; applies herbicides; clears trails.
- o Monitors wetland sites; ensures gates are locked and signs are properly posted; monitors for evidence of trespassing; cuts grass.
- o Flushes fire hydrants.
- o Performs miscellaneous landscaping; applies mulch, fertilizer, and pine straw; installs sod; installs and maintains flower beds.
- o Transports equipment to and from job sites.
- o Maintains docks at lakes.
- o Maintains vehicle and equipment.
- o Performs other related duties as assigned.

KNOWLEDGE REQUIRED BY THE POSITION:

- o Knowledge of department policies and procedures.
- o Knowledge of relevant safety standards.
- o Knowledge of the tools and techniques of ground maintenance.
- o Skill in the maintenance and repair of lawn maintenance equipment.
- o Skill in the safe operation of an assigned vehicle.

SUPERVISORY CONTROLS: The Water Treatment Plant Manager assigns work in terms of somewhat general instructions. The supervisor spot-checks completed work for compliance with instructions and established procedures, accuracy, and the nature and propriety of the final results.

GUIDELINES: Guidelines include county policies and procedures, safety regulations, and department standard operating procedures. These guidelines are generally clear and specific, but may require some interpretation in application.

COMPLEXITY: The work consists of related grounds maintenance duties. Inclement weather contributes to the complexity of the position.

SCOPE AND EFFECT: The purpose of this position is to maintain plant related wetlands and other property. Success in this position contributes to well maintained grounds and wetlands.

PERSONAL CONTACTS: Contacts are typically with co-workers and members of the general public.

PURPOSE OF CONTACTS: Contacts are typically to give or exchange information; resolve problems; and provide services.

PHYSICAL DEMANDS: The work is performed while intermittently sitting, standing, stooping, bending, crouching, or walking. The employee frequently lifts light and heavy objects, climbs ladders, and uses tools or equipment requiring a high degree of dexterity.

WORK ENVIRONMENT: The work is typically performed outdoors. The employee may be exposed to dust, dirt, grease, machinery with moving parts, irritating chemicals, and cold or inclement weather. The work requires the use of masks, goggles, and gloves.

SUPERVISORY AND MANAGEMENT RESPONSIBILITY: None.

SPECIAL CERTIFICATIONS AND LICENSES: Possession of a valid State of Georgia driver's license (Class C) and a satisfactory Motor Vehicle Record (MVR) in compliance with County Safety and Loss Control Guidelines. Completion of the State of Georgia Department of Transportation Defensive Driving Course and/or Emergency Vehicle Operation Certification within twelve (12) months of employment.
