### **Old Business:**

#### Hall of Fame:

- Mr. Tray Baggarly and Mr. Joe Crain, Sr. provided the Fifteenth Annual Induction Banquet program for February 11, 2017. Thank you to Lisa Mahaffey for coordinating the visit by these gentlemen.
- Fayette Recreation Commission asked Mr. Beggarly and Mr. Crain to explain how their Hall of Fame program worked.
- Inside the program, it lists the criteria for Hall of Fame candidate.
- Mr. Crain mentioned that this has been done for 15 years and went over some do's and don'ts

- Scholarship to a student from four local schools. A committee was created and award was given to student with the most need.

#### **New Business:**

Confusion of the names of local youth football leagues:

#### Mr. Mark Brown:

"Fayette County Youth Football" to be an inclusive football league for those in county. Organization would like to work with other football leagues in the county. However, other leagues such as Blue Devils, Sandy Creek youth football have had quite a bit of backlash regarding signs being placed at schools with Fayette County Youth Football written on signage. The names are too similar.

Mr. Brown was notified that Fayette County Youth Football has a 5013C and has the same name for 50 years.

Mr. Brown informed Mr. Dwayne Thomas that if there are signs in the schools that read that, to "Take them down and throw them away."

- Mr. McCollum informed Mr. Brown to change the name of the team so it does not mirror Fayette County youth football.
- · Mr. Brown understood the confusion.
- Mr. Latmer of Sandy Creek Youth Football said that he and the Blue Devils have a great working relationship with each other even though they play each other.
- Sandy Creek Youth Football has approximately 150 kids.
- Charles instructed Dwayne Thomas (and Mr. Geiger and he agreed) to put on Facebook that a meeting was held and the situation is resolved. There isn't anyone encroaching on football teams.
- Control Fights at the parks during tournaments. A "Zero Tolerance Policy" will be read during games and put on Facebook. Visiting teams will be notified in writing and notified in the be-

ginning that if a violation occurs, they will not be asked to come back and registration fees will not be accepted.
