**Transportation Plan Update:**

There will be an open house on 3/18/19 from 4-7pm at the Fayette County Library to allow citizens to see the Transportation Plan and make recommendations regarding their desires for things such as multi purpose trails/paths and ways to make areas safer and user friendly for residents. ### **New Business:**

#### **Tennis Courts:**

A discussion took place regarding existing tennis courts at the county parks. A question was raised about potentially charging high schools using these facilities for team practices. Lisa Mahaffey will contact the Peachtree City Tennis Center to inquire what fees they charge local Fayette County Schools for their facilities.

#### **McCurry Fencing:**

A proposal to reconfigure parking and add fencing for safety reasons to McCurry Park was discussed. This concerns the area between the maintenance building and the softball fields where people are cutting through to walk the trails and are not visible to maintenance trucks driving through the area. Lisa Mahaffey made a motion to accept. Bryan Thompson 2<sup>nd</sup> the motion. Motion passed 4-0.

### **Public Comment:**

Teresa Davis representing the Fayette County High School Tennis Program raised concerns regarding the ability to reserve all four tennis courts at the Kenwood facility for the FCHS team practice Monday-Thursday afternoons. There has been a local resident expressing interest in playing on the Kenwood courts during that time since Kenwood does not have night-time lights. A suggestion was made by Charles McCollum to allow one of the four courts for public use by reservation. If the court is not reserved, then FCHS would be allowed the use of all four courts.

### **Staff Reports:**

Two volunteers from the commission are needed for the upcoming Needs Assessment, which was budgeted for 2019. Mike Gumbinger and Bryan Thompson volunteered to be the representatives.

Any Recreation Commission By Law changes need to be discussed next year at least 30 days prior to the Annual Recreation Commission meeting in order for them to be voted on and implemented at the Annual meeting.

There will be a PTC Rowing Scrimmage Saturday, March 16<sup>th</sup> at Lake McIntosh. Everyone is encouraged to attend.

### **Board Reports:**
