Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced Request for Ouotes (RFO). You will need to consider this information when preparing your quote.

1. When was the last time the fountain was operational?

The fountain was functioning properly two years ago.

2. Where is the cutoff valve for the fountain?

The fountain can be turned off by the water valve in the grass just inside the first ring around the fountain.

3. Do you have a preference on color for the missing tiles?

The missing tiles shall be replaced with a similar blue colored tile.

4. What kind of sealant is required?

Any product that will seal and protect the paint and tiles from the chlorine in the water.

5. What size bubble do you require at the top of the fountain?

The fountain shall maintain a 12" to 18" bubble of water at the top.

6. If there is damage to the electrical outlet, should we include that in the bid?

A line item has been added to the price sheet for any electrical issues that may arise (Attachment 1). Written permission is required to invoice for this line item.

7. If the fountain water line is clogged, do I replace the water line?

It has been determined that the water line is clogged. A new waterline shall be placed on the back side of the fountain away from the building and shall run from the base of the fountain to the top tier. A hole shall be drilled and sealed on all three tiers to accomplish this.

8. What GPH (Gallons per hour) is required for the alpine cyclone pond pump? The minimum of 2,600 gallons per hour which is the speed of the current pump.
