The Purchasing Department issued Request for Quotes #2268-A to secure a contractor to install new flooring into the Public Works Building. Notice of the opportunity was emailed to 45 companies. Another 268 were contacted through the web-based Georgia Procurement Registry, who had registered under commodity code #36060 (Special Flooring, Industrial: Resinous, Elastomeric Liquid, etc.) and #91025 (Flooring Maintenance and Repair, Including Refinishing and Sealing Services). The offer was also advertised through Georgia Local Government Access Marketplace, and the county website.

Four (4) companies submitted quotes (Attachment 1).

The Buildings and Grounds Department recommends CAD's Home Improvement. This company has not contracted with the county in the past, so a Contractor Performance Evaluation is not attached. A positive response from all their references were received.
