Below, please find responses to questions, clarification, or additional information for the above referenced Request for Quotes. You will need to consider this information when preparing your quote.

1. Would the County be interested in doing the physicals onsite via a mobile unit?

Yes.

- 2. Will you consider a mobile health testing vendor who will bring all necessary equipment to one of your fire stations to perform the testing? Yes, but any on site testing would be held at our training center and not at a fire station.
- 3. What shift schedule do you follow? 24/48
- 4. As a mobile provider, we generally have a fee schedule with daily equipment and labor fees. Can we add any line items to your pricing sheet?

Line items may not be added to the *Pricing Sheet*. Daily equipment fees, labor fees, and any other applicable charges should be reflected in the unit prices you quote.

5. Who is the incumbent?

Well Street (formerly, Summit Urgent Care)

6. We offer physicals which include a MET (metabolic equivalent) test which takes the place of the spirometer and EKG. It is a stationary bike while the firefighter is wearing a mask to measure their cardiac and lung capacity. Is this an option to quote?

No. The testing needs to remain as stated in the RFQ.

7. Can the contractor come on-site to perform these physicals or the x-ray portion of the physicals?

Yes. This can be arranged with the Contractor.

8. Will you accept bids that sub-contract x-ray?

No sub-contractors will be allowed.
