Included herein is additional information and clarification for the above referenced request for proposals. Please consider all of this information when preparing your proposal.

#### **1. Whether companies from Outside USA can apply for this (like; from India or Canada)?**

Fayette County can consider proposals from companies headquartered outside the United States if:

- (1) They have a legal presence with staff in the United States,
- (2) They store all electronic data in the United States,
- (3) They can guarantee to the county's satisfaction that the data would not leave the United States, and
- (4) Data security would meet all relevant requirements and standards. The company must be in compliance with the State of Georgia's immigration compliance (E-Verify) requirements. In addition, concerns about acceptable after-the-sale service, dispute resolution, and other relevant topics must be addressed.

**2. Whether we need to come over there for meetings?** Short listed vendors may be required to make a live presentation at Fayette County for the Evaluation Committee and Procurement Staff. The successful vendor may need to meet at Fayette County during start-up and implementation stage(s).

**3. Can we perform the tasks related to the RFP outside USA (like; from India or Canada)?** Answered in question #1.

#### **4. Can we submit the proposals via email?**


