### **Call to Order by Chairman Randy Ognio**

### **2. We will elect the chair, vice chair and secretary for 2017.**

### **3. Jon Rorie will come and present the GDOT plans in detail for HWY 54/74.**

Mr. Rorie was out ill so he sent Mr. Borkowski in his stead. Peachtree City, City Engineer David Borkowski, presented gathered information on the traffic study results of Hwy 54 and Hwy 74 intersection. The committee discussed the 2040 Continuous Flow traffic plan GDOT has for the intersection. The committee did not take action on this matter.

### **4. Phil will provide an update from Fayette County Public Works on 2004 Transportation SPLOST Activities.**

Mr. Mallon provided 2004 Special Purpose Local Option Sales Tax (SPLOST) funds documentation to the committee for review, suggestions, and approval. He explained that once the Transportation Committee reviewed the documents they would be added to the SPLOST general public presentation and the county website for viewing.

Ms. Robinson suggested that the information is minimalized, so as to not confuse it with SPLOST 2017. The committee will review the information and send any suggestions to Mr. Mallon. He will revise the documentation and email it out to the committee.

### **5. Other business, if any.**

Mr. Mallon discussed the three large transportation comprehension studies planned for 2017. One of the projects is a path plan for the county. That project will unofficially begin this Friday, January 13, 2017 with a GDOT Project manager coming to see the path system in effect.

It was noted that the next meeting of the Transportation Committee was scheduled for February 7, 2017. We will have a representative from GDOT to come and talk about golf cart usage inside of state route right of ways.
