Meeting Minutes

November 7, 2017

4:00 P.M.

Call to Order by Chairman Randy Ognio

Chairman Ognio called the November 7, 2017 Transportation Committee meeting to order at 4:04pm

Chairman to acknowledge that a Quorum of the Transportation Committee is present.

Approval of the Agenda as published.

The agenda was changed to move number 5 from new business to unfinished business number 4. Mrs. Robinson motion to approve the new agenda and Chairman Oddo second the motion. The motion passed 10:0:1 with Lt. Gary Farr absent.

MINUTES:

Approval of the October 3, 2017 Transportation Committee Meeting Minutes. Ellen Walls and Lt. Gary Farr were not present for the October 3, 2017 meeting. *Pages 3-8.*

Mrs. Robinson moved to approve the meeting minutes with a change to add the discussion of moving future meetings to 2pm instead of 4pm. The minutes have been updated to include the discussion. Jaimi Tapp seconds the motion. *The motion passed 9:1:1, Ellen Walls abstained since she was absent on October 3 meeting and Lt. Farr was not present.*

REPORT OF COMMITTEE:

PUBLIC COMMENT:

Chuck & Cindy Repine lives on Sandy Lake Circle came to ask for assistance with traffic during the Gaddy's Christmas Light display. Mr. Repine asked for cones to be put down and suggest right turns only. Mrs. Ellen Walls suggested getting an off duty officer to direct traffic. The commit will discuss it further and will provide a solution to Mr. Repine.

Holly Grisamore spoke concerning the number of speeding cars on Quarters Road.

Commissioner Oddo motioned to move the agenda item number 3 to number 1. Mrs. Robinson second the motion was approved 10:0:1 with Lt. Farr absent.

Mrs. Winnie came in after public comments were made. She wanted to check on the status of stopping trucks from accessing Tyrone Road, Dogwood Trail and Farr Road.

UNFINISHED BUSINESS:

1. **Quarters Road 4-way stop sign request update with traffic data.** Mr. Mallon led the discussion of the traffic data gathered from Trotters Ridge and Quarters Road intersection. There was one crash reported in the 2 intersections in 2015. The data does not justify the instillation of a 4-way stop. The Transportation Committee motioned to :

- Put "stop for pedestrians" signs at the pedestrian crossing located at the Tarragon Road, Highgrove Drive and Trotters Ridge.
- Include the Highgrove SD into the county Transportation Study
- Check permits for golf cart crossing on Quarters Road;
- Speak with the sheriff department to put in a speed monitor.

The motion was created by Mrs. Robinson and second by Mrs. Wells. The motion was approved 10:0:1 with Lt. Farr absent.

2. **Traffic Calming Policy – update of revision;**

Mr. Mallon stated the policy is waiting to be reviewed by the county attorney and the Board of Commissioners.

3. **Transportation Committee Meeting 2018 revised schedule attached. *Page 9***

Mrs. Robinson motioned to table this item until December 5th meeting to discuss meeting time. Carlos Christian seconds the motion. *The motion was approved 10:0:1 with Lt. Farr absent.*

4. **Millpond Manor multiuse path to Starr's Mill High School Complex – Commissioner Ognio;**

Donnie Walker came to the Transportation Committee meeting asking permission to pave the existing cart path through county property. This path will be paved and used by Mill Pond Manor Subdivision. Mrs. Tapp motioned to have the Transportation Committee present the request to the Board of Commissioners and asks for permission to research options to resolve the associated issues. Mrs. Robinson seconds the motion. *The motion passed 10:0:1 with Lt. Farr absent.*

5. **2004 SPLOST approved projects review – Phil Mallon will expand on 2004 SPLOST uncompleted project chosen for completion.**

Mr. Mallon reviewed the 2004 SPLOST revised project chart from the October 3rd meeting. Input from Committee members will add additional changes to the chart.

Brian Wismer joined the November meeting to replace LaShawn Gardiner for The City of Fayetteville. He covered details of the 2004 SPLOST S-3 Lafayette Avenue Streetscape Improvements project. Opening Lafayette Ave to east west traffic will add another stop light on SR 85. However it will add access to the hotel and the local church while giving drivers exit options from SR 54 and SR 85.

NEW BUSINESS:

6. GDOT McDonough Road widening project update – Phil Mallon;

The project is waiting for GDOT notice to proceed to start the project. This item is tabled for discussion with GDOT in December 5th meeting.

7. Additional updates.

Mrs. Walls motioned to adjourn the meeting at 6:05pm. Mrs. Robinson seconds the motion. The motion passed 10:0:1 with Lt. Gary Farr absent from the meeting.
