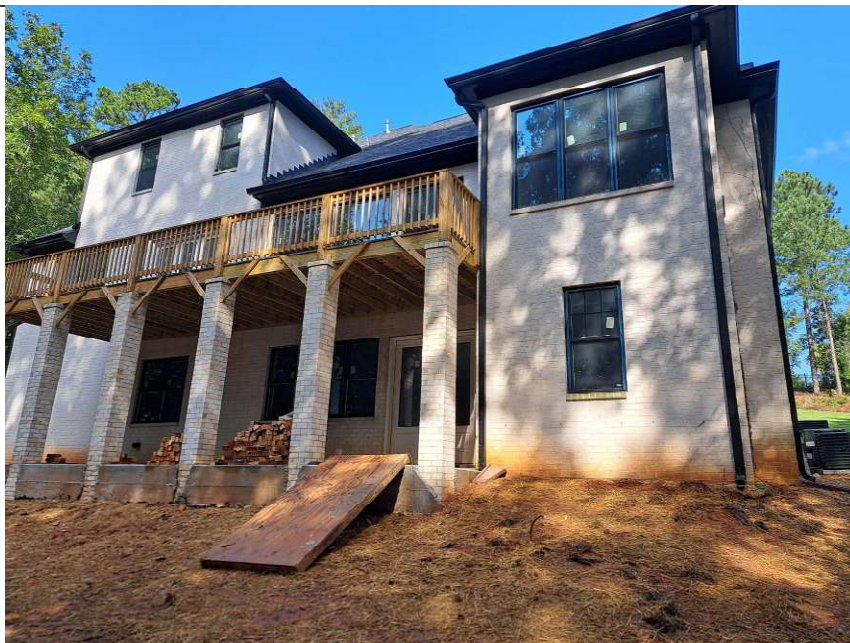

Comments for Flood Elevation Certificate

110 Ensley Point

Fayetteville, GA 30214

This structure is graphically shown to be in a Zone X (unshaded area) but is near to a Zone AE flood hazard. The base flood elevation shown on the certificate is based off the referenced flood insurance rate map. In addition, the recorded subdivision plat shows a detention pond on this lot with a ponding elevation of 832.48 and a required minimum finished floor elevation of 833.48. However, the flood hazard certificate provided by Fayette County notes a required minimum finished floor elevation of 835.48. In addition, the Fayette County 2013 flood study made available on the Fayette County GIS shows an Existing 100 Year elevation of 821.98 and a Future 100 Year elevation of 822.12. The flood hazard certificate provided by Fayette County is attached.

The machinery in section C2(e) is an outdoor HVAC unit. It should be noted that larger floods can and will occur, flood heights may be increased by man-made (pipe failures, cart paths, etc.) or natural causes. Visit www.fema.gov/flood to get a better understanding of flooding and flood insurance.
