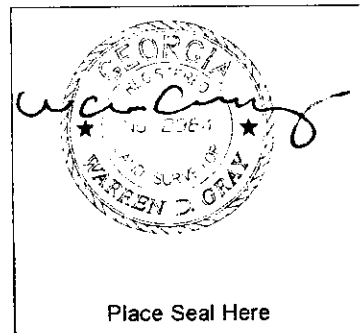

There is a required Minimum Finished Floor Elevation (MFFE) stated on the referenced plat of 877.6. The equipment in C2.e is an exterior air conditioning unit.
