According to graphic observation of the referenced FIRM, this house lies in a Zone "X" unshaded area. Per the attached Flood Hazard Certificate issued by the Fayette County Environmental Management Dept., the base flood elevation (BFE) is 784 with a required Minimum Finished Floor Elevation of 787. The required MFFE of 787 is also shown on the recorded S/D plat. According to the field elevations in section "C" the house and lowest adjacent grade are above the BFE. W D Gray and associates, did not participate in the establishment of the BFE. The machinery in section C is an outside HVAC unit.
