140 Lapis Lake Point, Fayetteville GA

Lot 363, Canoe Club at Waterlace – Pod F

The latitude and longitude were taken from Google Earth. The machinery in section C2(e) is an outside HVAC unit. Base flood elevation (869) is taken from the Fayette County Flood Hazard Certificate (attached). The certificate as well as the recorded final plat show a required minimum floor elevation of 872. Fayette County has previously indicated that the vertical datum for their flood data is NAVD 88. By scaling from the referenced flood insurance rate map, a portion of this property as well as a portion of the structure are graphically shown to be in a Zone A (no base flood elevation determined) flood hazard area. It should be noted that larger floods can and will occur, flood heights may be increased by man-made (pipe failures, cart paths, etc.) or natural causes.
