This structure is graphically shown to be in a Zone X (unshaded area). The recorded subdivision plat shows a "100-year flood elevation" of 809.0 and a required minimum finished floor elevation of 812.0. The flood hazard certificate provided by Fayette County states a base flood elevation of 809 and a required minimum finished floor elevation of 812. The flood hazard certificate provided by Fayette County is attached. Neither the subdivision plat or the flood hazard certificate state the vertical datum of the flood elevation. It has become commonly understood that flood hazard certificates from Fayette County are on the NAVD 88 datum. Elevations shown on this certificate are NAVD 88 per the EGPS real time network.

The machinery in section C2(e) is an outdoor HVAC unit. It should be noted that larger floods can and will occur, flood heights may be increased by man-made (pipe failures, cart paths, etc.) or natural causes.
