The equipment used for this Elevation Certificate included a Carlson BRx7 Base & Rover and a Carlson CRx5 Robotic Total Station. The Base Flood Elevation (BFE) was determined using the 100-year headwater elevation for a 30" RCP under Lees Lake Road. David Hovey, P.E., established this elevation at 890.91 feet. The lowest finished floor of the residence on the property is at 894.48 feet, which is 3.57 feet above the BFE. (C2 e = A/C Pad)

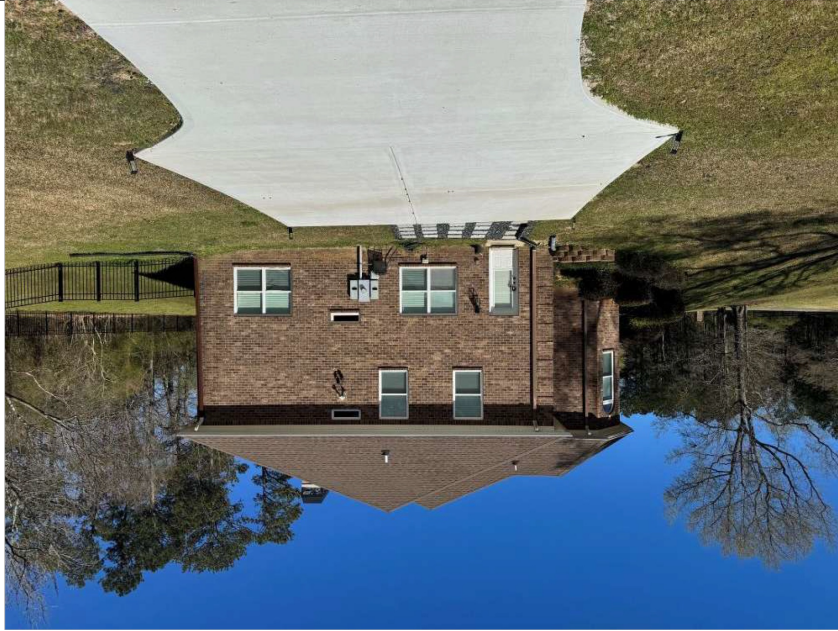
