Comments for Flood Elevation Certificate

338 Dogwood Trail, Tyrone GA 30290

Tract 3, Dogwood Farms as shown on Plat Book 102, Page 117

The latitude and longitude were taken from Google Earth. The machinery in section C2(e) is an HVAC unit located in the garage area. This structure appears to have a lower level being a garage/drive in area. The upper level appears to contain a living space. Base flood elevation (874.96) is taken from the Fayette County Flood Hazard Certificate (attached). The Fayette County GIS Website (qpublic.net) as well as the recorded subdivision plat shows Fayette County 100-year flood plain cross-sections across this lot. The cross sections vary in elevation from 871.42 (East of the subject property) to 895.72 (far West side of the subject property). The referenced flood insurance rate map graphically shows that a portion of this property contains a Zone A (no base flood elevation determined) flood hazard area. By graphic scaling, it appears this structure is outside the Zone A area. It should be noted that larger floods can and will occur, flood heights may be increased by man-made (pipe failures, cart paths, etc.) or natural causes.
