The latitude and longitude were taken from Google. Base flood elevation (907.82) is taken from the Fayette County Flood Hazard Certificate (attached). It notes a required minimum floor elevation of 910.82. The machinery noted in C2(e) is an outside HVAC unit. According to the referenced flood map, this lot does not lie in a special flood hazard area. It should be noted that larger floods can and will occur, flood heights may be increased by man-made (pipe failures, cart paths, etc.) or natural causes.
