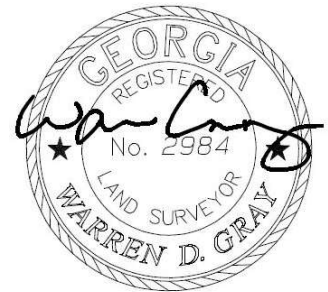

Per the referenced flood insurance rate map, this MH is graphically shown in a Zone "X" unshaded designated area. However, per the attached Flood Hazard Certificate, the Base Flood Elevation is 891.64 and the required Minimum Finished Floor Elevation is 894.64. This MH and lowest adjacent grade to the MH is above and out of the 100 year flood plain. W. D. Gray and Associates, Inc. did not participate in establishing the Base Flood Elevation. The machinery in section "C" (C2e) is an outside HVAC unit. A map of the mobile home park showing this home location is also attached.
