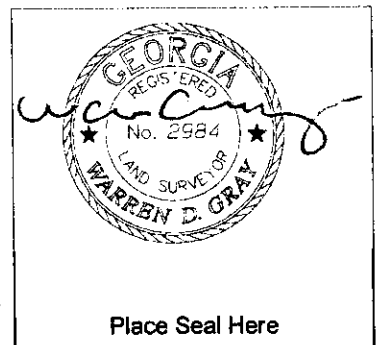

Per the referenced flood insurance rate map, a portion of this MH is graphically shown in a Zone A (no base flood elevation determined) flood hazard area and a portion is in a Zone "X" unshaded designated area. However, per the attached Flood Hazard Certificate, the Base Flood Elevation is 871.28 and the required Minimum Finished Floor Elevation is 874.28. This MH and lowest adjacent grade to the MH is above and out of the 100 year flood plain. W. D. Gray and Associates, Inc. did not participate in establishing the Base Flood Elevation. The machinery in section "C" (C2e) is an outside HVAC unit.
