1. Phase I was submitted via mail. 2. Please clarify when the presentation for the interview is due. On page 1 of the Notice to Selected Finalists, 3<sup>rd</sup> bullet, under "Page 16, D. Interview (30-Minute)", it says "Please prepare a 15-minute presentation...no later than February 13, 2026". Then, a little further down, it says "An electronic file version of the presentation shall be forwarded via email no later than 9am on the morning of the scheduled interview". But the presentation, as noted on page 2, in the table under "Phase II", says the "Phase II Response of Finalist firms due" is on February 13. And interviews, where the presentation will take place, are on March 5-6. So, should the presentation be submitted by 9am of February 13? Or by 9am on March 5-6?

Our apologies on the confusion. Phase II Responses are due 2/13/2026.

If a company is asked to participate in an interview, and if they elect to have a presentation for the interview (not required), the presentation should be forwarded to Sherry White at [swhite@fayettecountyga.gov](mailto:swhite@fayettecountyga.gov) no later than 9:00 am on the morning of the scheduled interview (i.e, on March 5 or 6).

3. On page 1 of the Notice to Selected Finalists, 2<sup>nd</sup> bullet, it says "Pages 23, VIII. Instructions for Submittal for Phase II – Technical Approach and Past Performance Response, A-D". When we pull up that title up in the RFQ (actually under section IX.), bullet "A." instructs firms to "follow the format and meet the content requirements identified in Section VII, entitled Instructions for Preparing Technical Approach and Past Performance Response – Phase II Response. See **Attachment 1** for a summary of how the submittals should be prepared." Pulling up Section VII, there is no mention of Attachment 1. Is there supposed to be an attachment that covers Phase II?  
**No, there is not an equivalent "Attachment 1" for Phase II. Please note, however, the Phase II instructions, including page limits, provided in "VII. Instructions for Preparing Technical Approach and Past Performance – Phase II Response."**
4. This bullet references project completion by February 13, 2026. Can you please clarify the date that project completion is expected?

5. Will we be contacted for interview scheduling after Phase II responses are submitted on 2/13/26? Those will take place on March 5<sup>th</sup> & 6<sup>th</sup>, correct?
