## **HOW DO CANDIDATES QUALIFY?**

Candidates are required to file paperwork and pay a qualifying fee within specific timeframes called qualifying periods in order to be considered qualified for office. The dates and times of the opening and closing of the qualifying periods are provided in O.C.G.A. § 21-2-132(d)(3).

Failure to complete the process during these time periods or improperly completing the process can prevent a candidate from being on the ballot.

## QUALIFYING PROCESS

In order to complete the qualifying process, nonpartisan (municipal) candidates will need to complete and submit the:

### **NOTICE OF CANDIDACY AND AFFIDAVIT**

and pay the qualifying fee for the desired office.

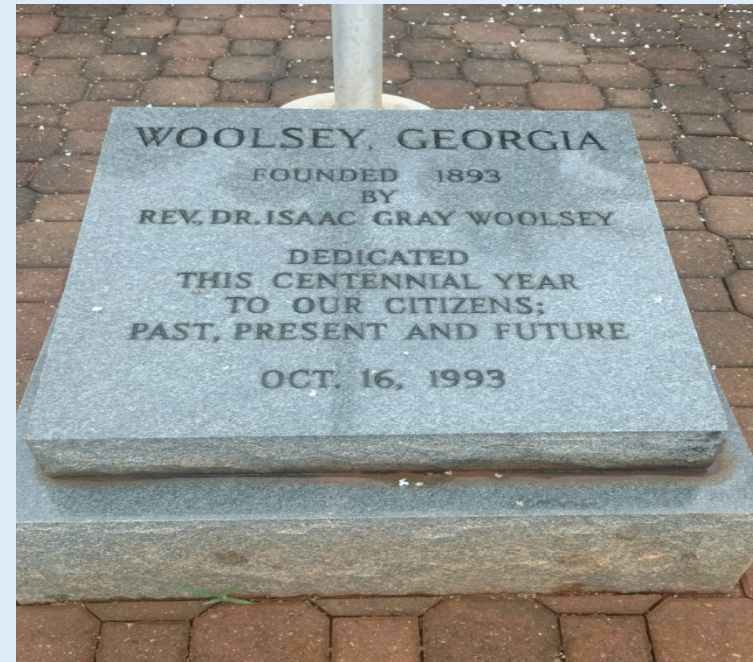

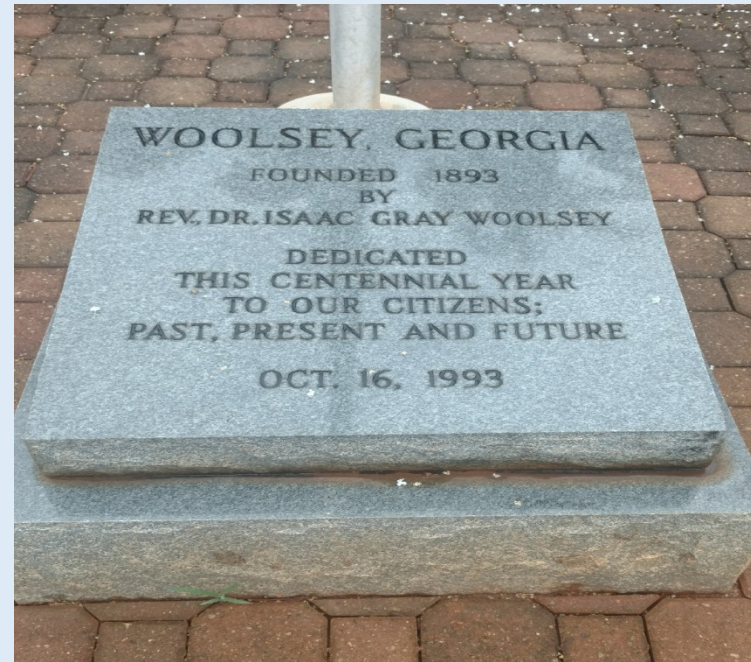

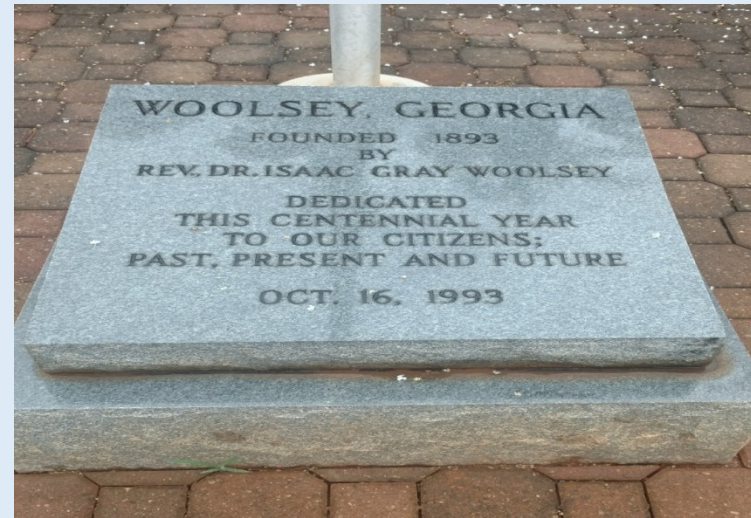
