Hall of Fame:

Due to last year's numbers, the county planned for large numbers, but there was a smaller turnout (approx. 3500) possibly due to impending bad weather. Everyone was able to get on the balloons who desired to. Feedback from the community was very positive about how well organized the event was, and social media posts were positive. One piece of feedback was adults would like to see more adult focused opportunities next year – there was plenty for kids to do. This idea will be explored. Relay for Life was held in May 2017, but weather impacted their event. On July 15, 2017 at 8:30pm, the Luminaire part of the event will be held.

Signage at the parks is in the process of being updated. No smoking signs will be incorporated into the main signs at the parks for greater visibility. They will incorporate pictures, when possible, instead of a long list of rules and regulations.
