Update on YAA Manual:

New \$25 non-resident impact fee beginning in January 2018. Background checks for president and treasurer to be completed prior to taking office. Coach must complete prior to first practice to be turned into the Recreation Department. Must be completed every season.

Concession Stand Guidelines:

Outdoor grills must be covered (10x10 pop up cover is acceptable). Recommend 18 years older to work the grill. Rotate Stock and must have drip mats. No grease spills allowed.

Tournaments:

Two week notice is required in order to notify law enforcement, fire, etc. Post Rules on website or Facebook for visitors.

• Financial Account Guidelines:

All Revenues and Expenses Reports turned into Anita. Be detailed, maintain receipts, anything over \$1,000 needs board approval

Safety Plans:

Many responsibilities are in the policy and procedure manual.

Include them on website.
