The Tax Assessors Department has submitted in Fiscal Year 2022 budget for a qualified consultant to provide Business Personal Property Audit Services. The service will verify the accuracy of Business Personal Property Tax Reports filed by Fayette County business taxpayers.

Toward this end, the Purchasing Department issued Request for Proposal #1945-P: Business Personal Property Compliance. Notices of the opportunity to propose were emailed to 6 companies that are on the County's bid list and/or responded to other similar solicitations. This Request for Proposal was also advertised on the Fayette County website, Fayette Newspaper, Local Channel 23, Georgia Procurement Registry, and Local Government Access Marketplace website.

There is a limited number of firms that perform business personal property compliance audits. Last time the county solicited for this service, two firms submitted proposals. The two qualified firms that submitted proposals last time also submitted proposals in response to this RFP. One additional company submitted so the total number of companies was three.

Based on the proposal criteria the highest scored company on technical and price, Mendola Consulting, LLC is being recommended for award. Mendola Consulting, LLC is the current vendor. The Evaluation Committee decided based on technical and price scoring, presentations were not needed. Evaluation scoring sheet is attached.
