Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced Request for Quotes. You will need to consider this information when preparing your quote.

1. Does the proposal require that the bidder purchase and supply the vending machines as part of the contract, or is the bidder expected to provide an estimate or plan for the purchase and placement of the machines for future use?

**Response:** The bidder will provide and maintain the machines as well as ensure each machine is restocked at reasonable intervals. The county will not be purchasing any of the machines.

2. How many vending machines are needed?

**Response:** We are requesting a total of 14 machines. (Attachment 1)

3. Are there specific snacks or required items needed in the machine?

Response: There are no specific snacks required; however, a list of suggestions is provided in the RFQ package.

4. Can you share the name of the current vendor for this RFQ?

Response: Firehouse Vending

5. Please share any monthly receipts from all 14 vending machines.

**Response:** That information has not been requested from or provided to the county by previous vendors.

6. If no receipts are available, can you tell me about how much revenue all 14 vending machines generate monthly or annually?

**Response:** That information has not been requested from or provided to the county by previous vendors.

7. When will this contract be awarded?

**Response:** This contract is scheduled to begin on July 1, 2025.

8. Can interested parties participate in a site visit?

Response: A pre-quote conference is not scheduled for this project.

9. It's stated that the machines shall be equipped to accept coins, \$1.00 and \$5.00 bills and to process electronic payments. Would you be interested in having the newer AI Smart Vending Machines placed in any of the 8 locations? However, these smart machines do not accept coin or cash payments. Payments are solely electronic, processed via tap, insert, or app.

Response: Machines equipped to receive coin, cash, or card payments are preferred.

10. The note below the pricing list states that "all applicable charges shall be included in your total quoted amount." Is this amount listed just so that you're aware of how much it cost us to place the machines or are you stating that you'll be responsible for some portion of these costs?

**Response:** For the 'Retail Price', we want to know the charge at the vending machine. For the 'Wholesale Price', we want to know only how much you pay your supplier for the product.

- 11. I understand that this is a non-commission-based contract, however, is it possible to review the gross sales or even estimates from the previous vending contract?Response: That information has not been requested from or provided to the county by previous vendors.
- 12. The picture for Water System seems to be a combination machine. Does this mean that a combo machine is acceptable for this low traffic location?

  Response: Ves. that would be acceptable for that location.

Response: Yes, that would be acceptable for that location.

13. What has been the revenue for all the subject locations for the most recent 12 months? Response: That information has not been requested from or provided to the county by previous vendors.

## INTRODUCTION

Fayette County is seeking a contract for vending services for employees and citizens that visit county offices using a third party vendor. This agreement will be a non-commissioned contract between the county and a vending machine company. The county has eight locations that require services.

- 1. **Purpose.** The Owner's business is located at 140 Stonewall Avenue West, Fayetteville, GA 30214 (hereinafter referred to as the "Premises"). The Vendor may place vending machines within the Premises of the Owner.
- 2. **Maintenance.** The Vendor shall maintain the vending machines in good and proper working order. This includes keeping machines clean and fully functional so as not to detract from the appearance of the Premises of the Owner.
