- 4. Contractor responsible for returning staging area and haul route to current conditions, including fine grading, sod/grassing, tree replanting, pavement/curb repair, and other items.
- 5. Bit Item No. 3 Traffic Control as per Construction Drawings sheet 11, "When using haul route, Contractor to provide flagman to ensure public safety."
- 6. Bid Item No. 4 Bush Hogging is provided to clear vegetation for the areas being excavated.
- 7. Bid Items No. 6 & 35 Contractor is fully responsible for disposal of all excavated sediment.

This Addendum forms a part of the Contract Documents and modifies the original Project Documents.

All other terms and conditions remain unchanged.

The opening date for this invitation for bids has not changed. The opening date will be Thursday, January 8, 2015 at 3:00 p.m. Bids must be received in the Purchasing Department at the address above in Suite 204 on or before the opening date and time.
